NARRATIVE On 05/16/24 at around 19:42 p.m., the front end of Unit 1 collided with the rear end of Unit 2 in an unknown manner on Seward Rd. just south of Union Centre Bv. Both Units were facing north at the time of the crash. The driver of Unit 1 stated that Unit 2 was in reverse and backing up in traffic prior to striking the front of Unit 1. The driver of Unit 2 stated that Unit 1 collided with the rear of her vehicle as she was stopped in traffic (assured clear distance ahead). 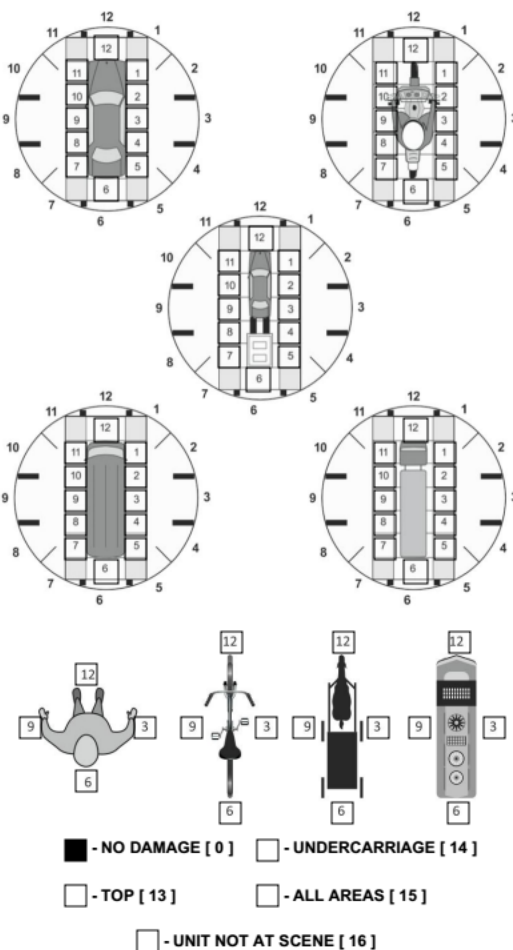

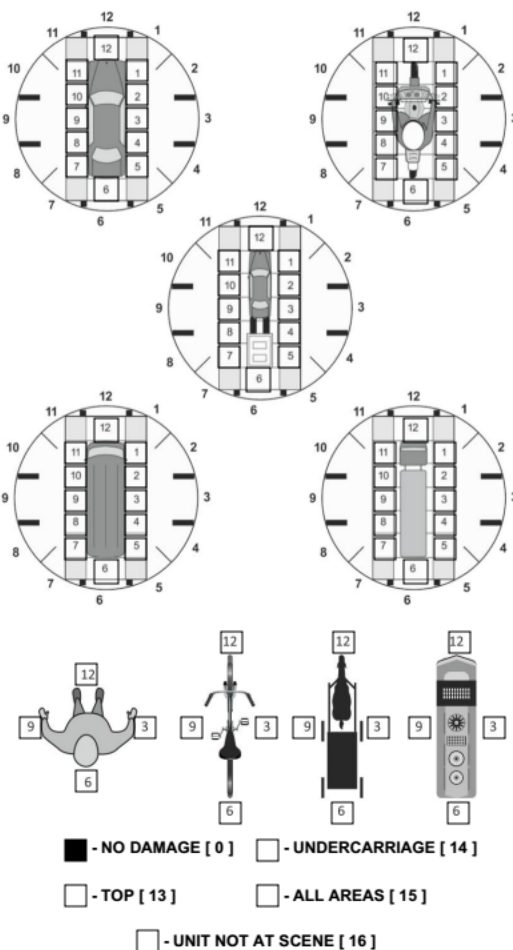
