NARRATIVE On 05-19-24 Unit #1 was northbound on Dixie Hwy. approaching Homeward Way. The driver of unit #1 told me on the scene she had a green light. I called her later on the phone and she told me that the light was yellow but had not changed to red yet when the crash occurred. Unit #2 was making a left from southbound Dixie Hwy. onto Homeward Way. The driver of unit #2 told me that he entered the intersection on a green light, the light changed to yellow then red. After waiting a moment at the red light he turned and was struck by unit #1. Unit #2 rolled over and came to rest on its passenger side. All parties agree that unit #1 was northbound on Dixie Hwy. and that unit #2 made a left turn in front of it and the two unites collided. Since the color of the lights is unknown no citation was issued. 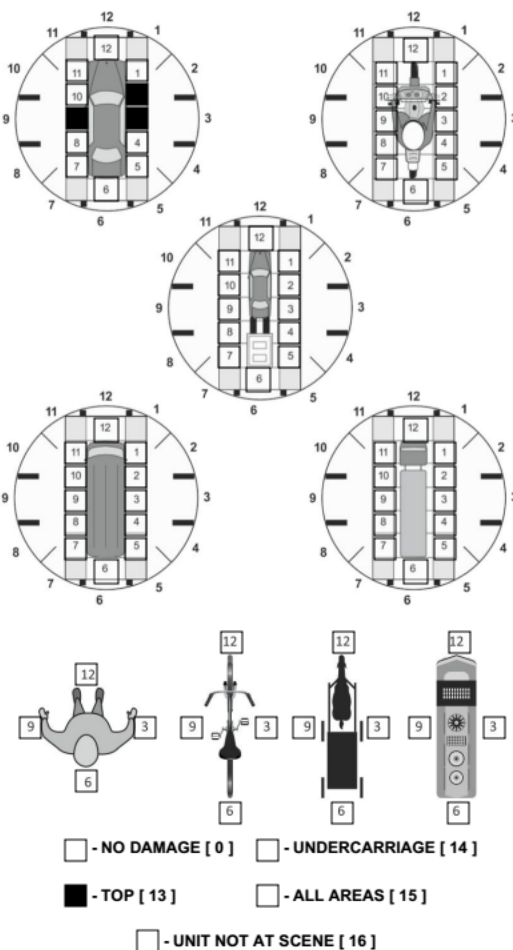
