Unit 1 was traveling east bound on Woodridge Blvd at approximately 30 m.p.h and when at 2851 Woodridge blvd. failed to stop within the assured clear distance ahead and collided with Unit 2 which was also east bound and was stopped in traffic at 3851 Woodridge Blvd. After being struck by Unit 1, Unit 2 was pushed forward, drove off the right side of the roadway and struck a fire hydrant. The fire hydrant is the property of the City of Fairfield (5230 Pleasant Ave. Fairfield, OH. 45014- The brake lights on Unit 2 were inspected and were working properly. 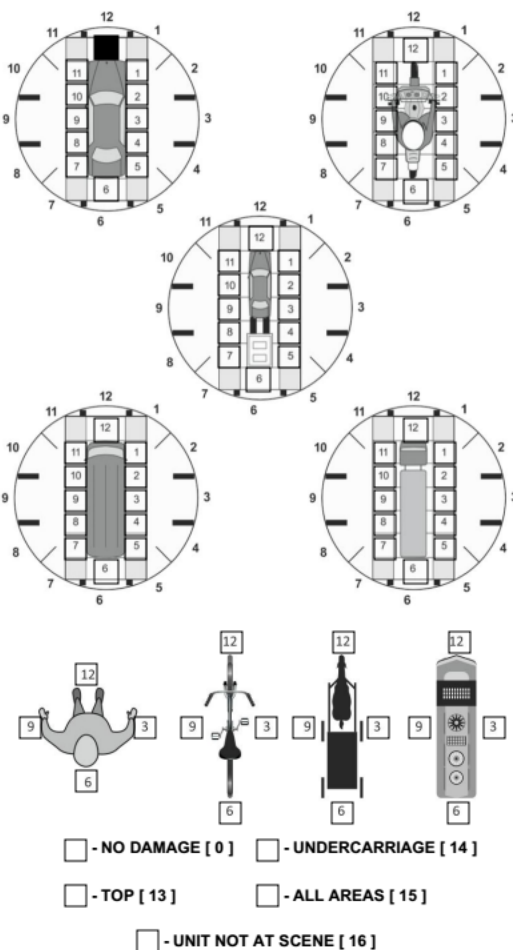

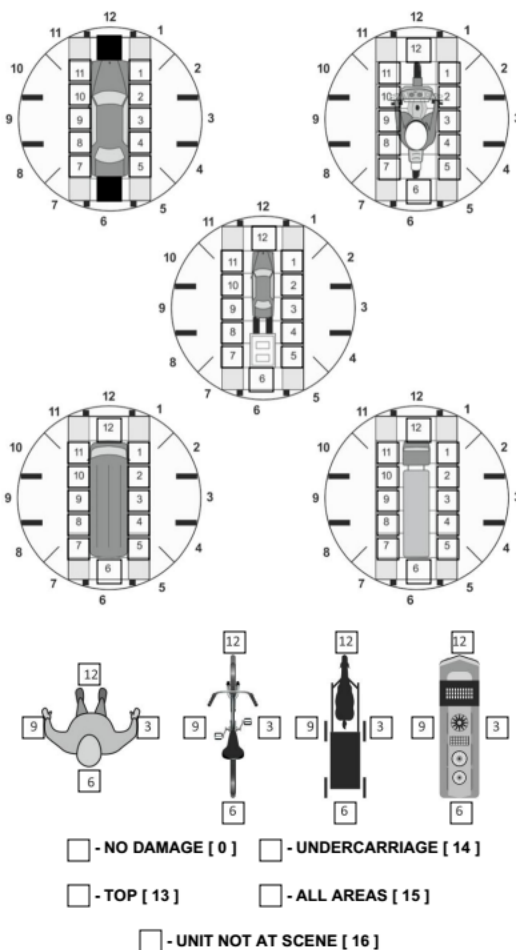
