Unit 1 was attempting to merge into westbound traffic from the eastbound lanes. Unit 1 while traveling at approximately 20 m.p.h. (in front of 1420 Nilles Rd) attempted to merge from the east bound left turn lane (of Nilles Rd) into the west bound left through lane of traffic in order to go west bound on Nilles Rd and in so doing collided with Unit 2 which was traveling west bound on Nilles Rd in the left through lane of travel at approximately 20 m.p.h. 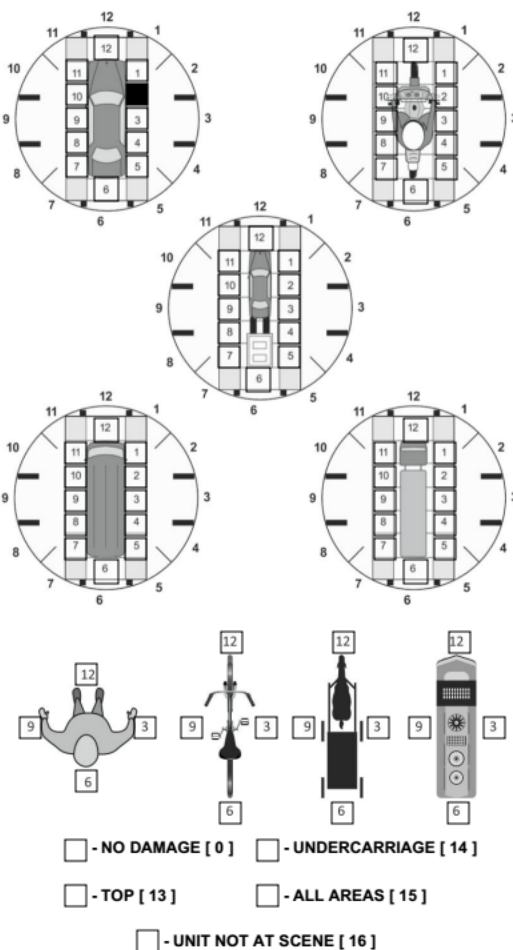

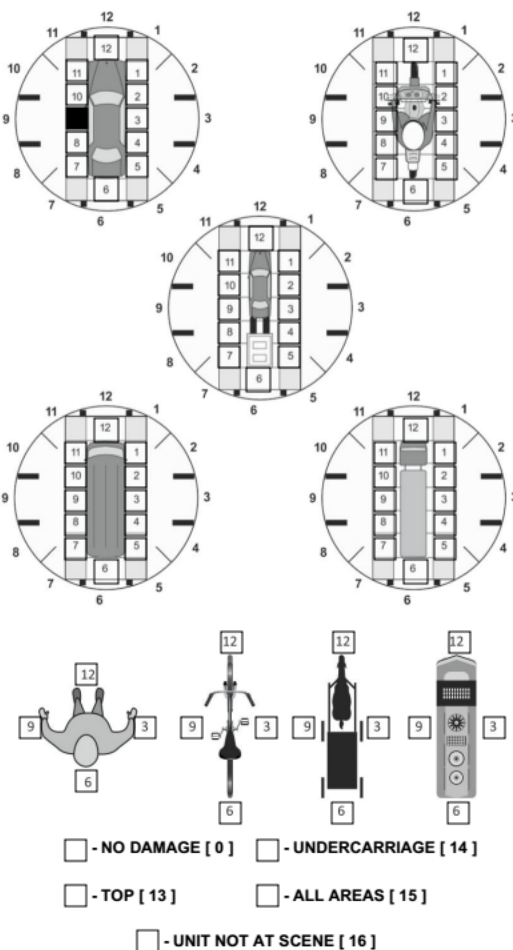
