Unit 1 stated Unit 2 came over into his lane of travel, causing the collision. Unit 2 stated Unit 1 attempted to pass on the left side of her vehicle, causing the collision.  Cameras were checked at Thortons, and the crash did not appear to be captured on video. Walgreens doesn't have cameras that face Ross Rd.  No parties were cited due to conflicting stories. 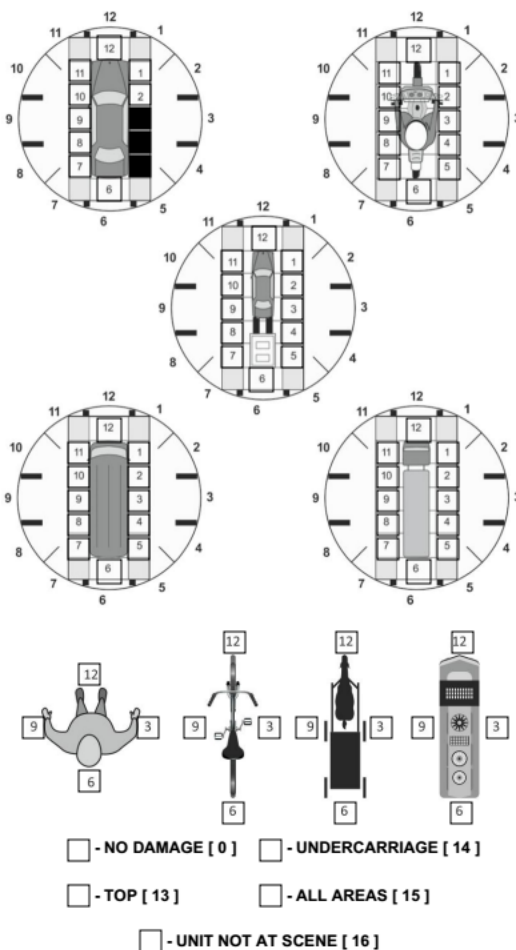

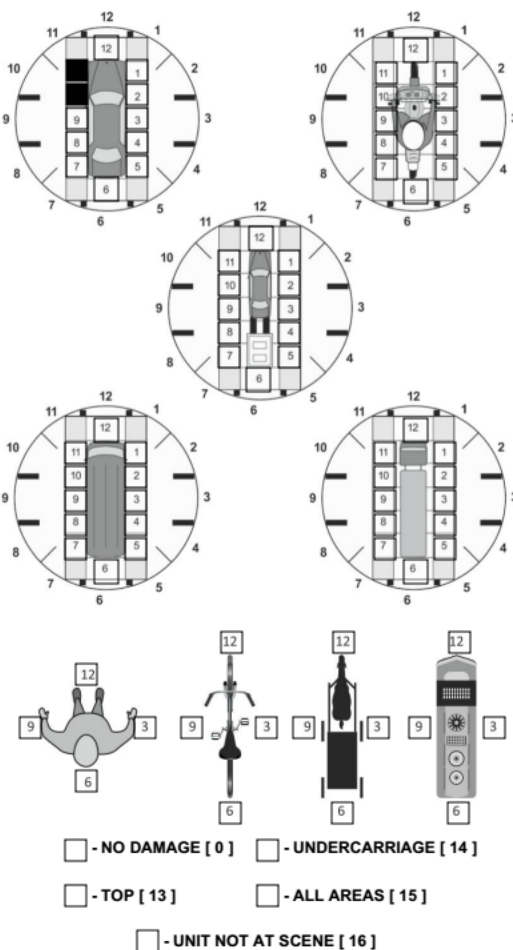
