NARRATIVE On 06/13/24 at around 4:30 p.m., Unit 1 was traveling southeast on Symmes Rd., and when near 2933 Symmes Rd., an object fell out of the back of Unit 1 and onto the roadway. At the same time, Unit 2 was also traveling southeast on Symmes Rd. and collided with the object. The object then became lodged into Unit 2's gas tank. 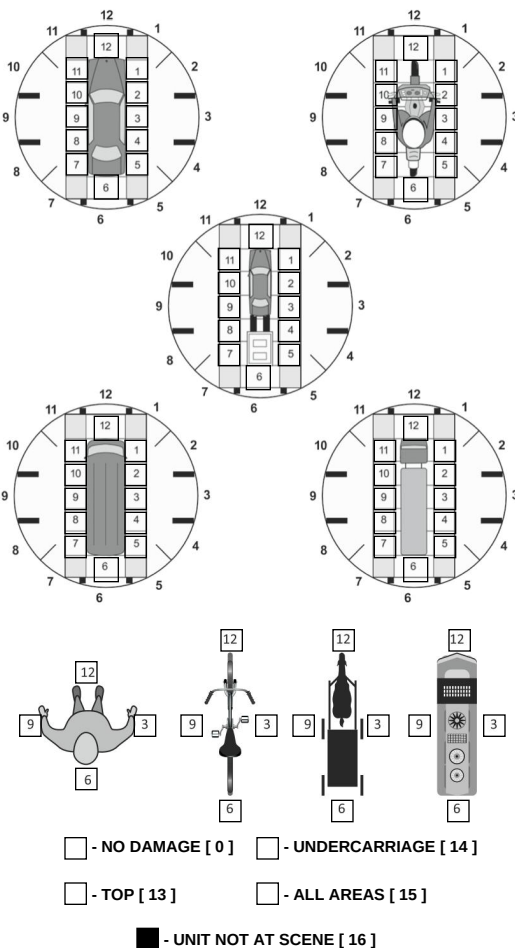

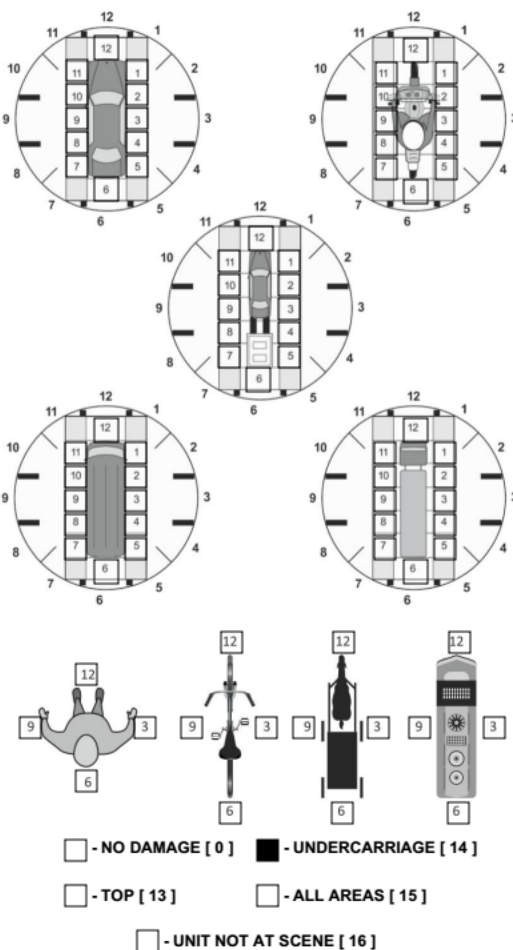
