



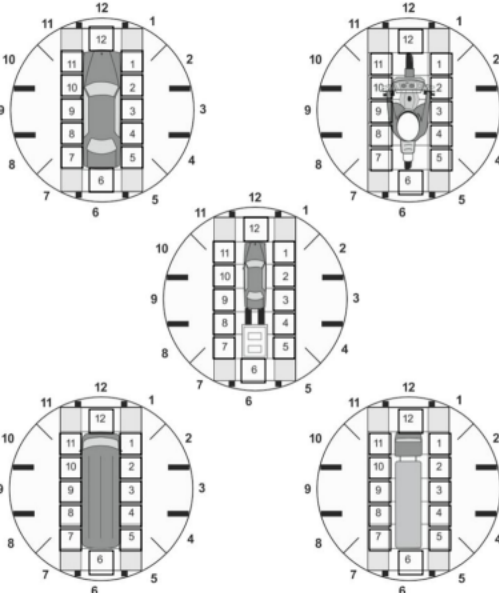

NARRATIVE On June 25, 2024 at 8:42 p.m Unit 2 was traveling south on Ross Road near Dixie Highway in the left lane. Unit 1 was also traveling south on Ross Road but in the right lane directly next to unit 2. The right lane ends, and must merge into the left lane. Unit 1 attempted to overtake/pass unit 2 when the right lane was ending. Unit 1 did not have enough room to overtake, side swiping unit 2 in the same direction. 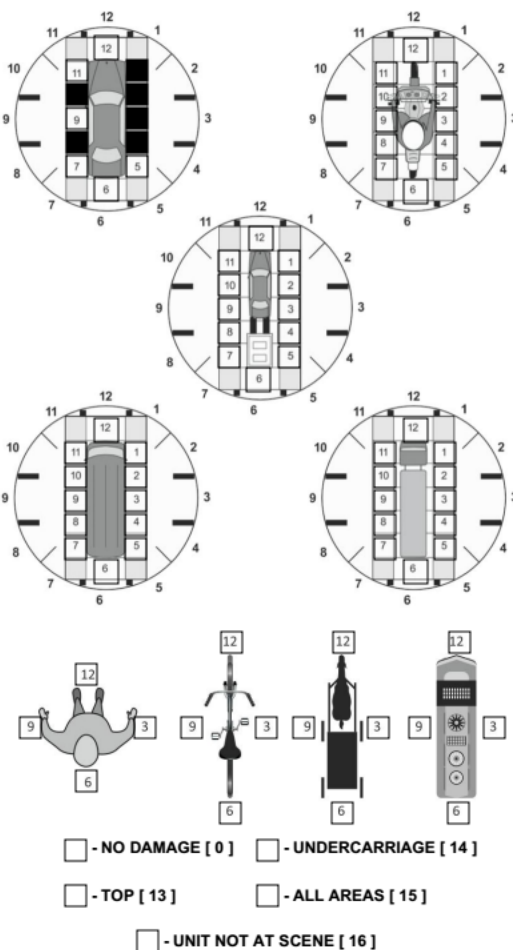
