NARRATIVE On 07/22/2024 Unit 1 was eastbound on Dixie Hwy in the 5540 block traveling in the right curb lane . Unit 2 was also traveling eastbound on Dixie Hwy. but was in the left through lane beside unit 1. The witness stated that unit 1 sped up and passed a vehicle that was traveling eastbound in left lane in front of unit 2 and then cut off that vehicle and made a two lane change going into the left turn lane approaching Holden Blvd. Unit 2 had already made a legal, single lane change into the left turn lane and had established its direction. When unit 2 made the two lane change attempting to enter the turn lane, it did not clear unit 2's bumper striking unit 2. The witness filled an OH-3 Statement that is attached to the report. 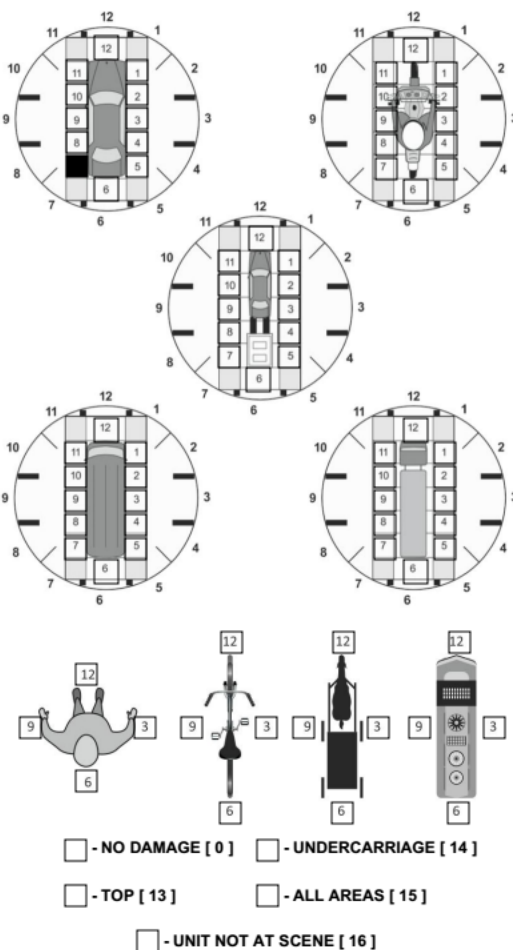
