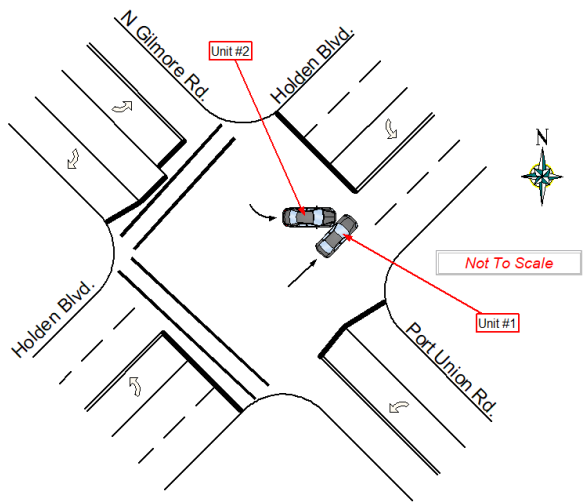

NARRATIVE On August 22, 2024 at about 7:50 A.M. Unit #1 was traveling northeast on Holden Blvd. and when at N. The driver of Unit #1 reported they received a green light at Holden Blvd. and N. Gilmore Road and began to proceed through the intersection when they were struck by Unit #2 who was making a left turn from N. Gilmore Road. The driver of Unit #2 reported they had a green signal and they entered the intersection to turn left from N. Gilmore Road to travel northeast on Holden Boulevard. The driver of Unit #2 stated they were completing the turn once the intersection cleared and were struck by Unit #1. 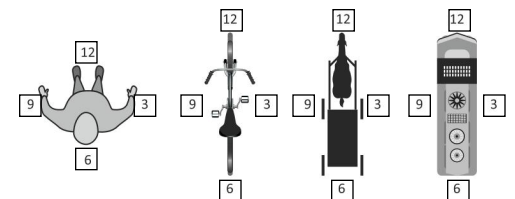
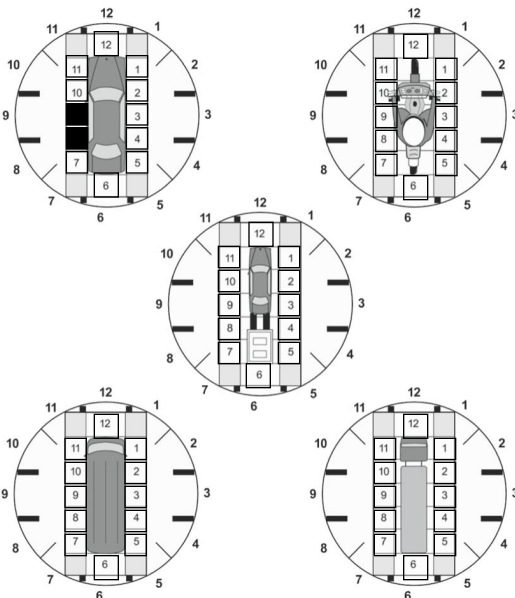

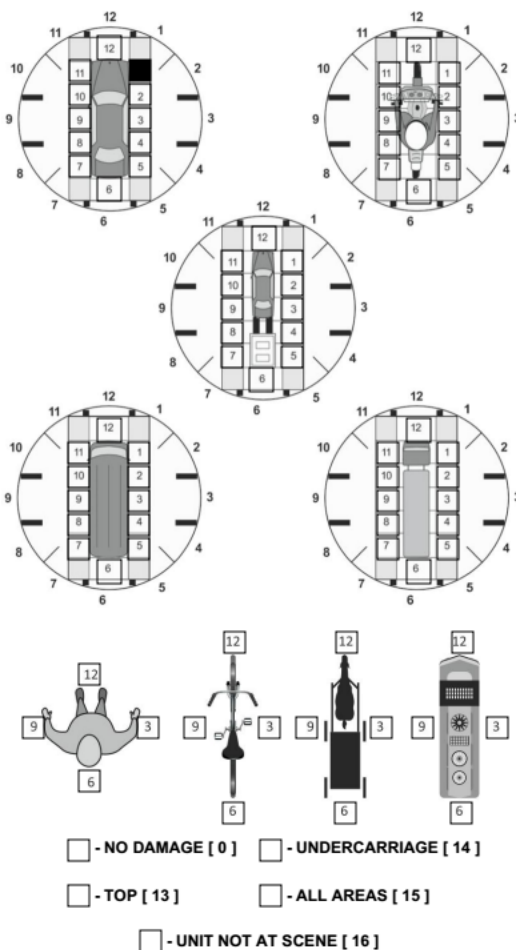
