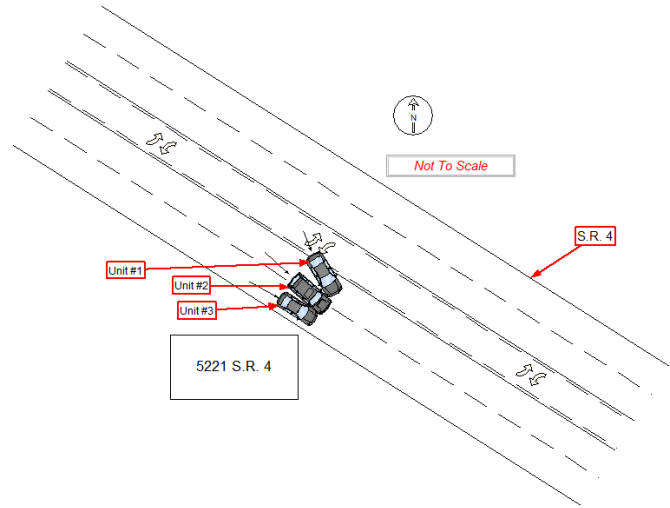

NARRATIVE On 08/31/2024 at 12:24 pm, the driver of unit #2 was traveling southeast on S.R. 4. When they reached 5221 S.R. 4, unit #1 was in the center turn lane, attempting to turn left into 5274 Dixie Hwy. However, a vehicle was traveling northbound on Dixie Hwy, forcing the driver of unit #1 to turn to the right and enter unit 2's lane. Unit #2 then turned the vehicle to the right to avoid a collision and ended up colliding with unit #3, who was also traveling southeast on Dixie Hwy in the curb lane. Unit #1 left the scene without leaving their information. There is no video footage in the area, which could have provided additional clarity. I am unable to determine the vehicle at fault in this crash due to conflicting testimonies and lack of concrete evidence.				DIAGRAM

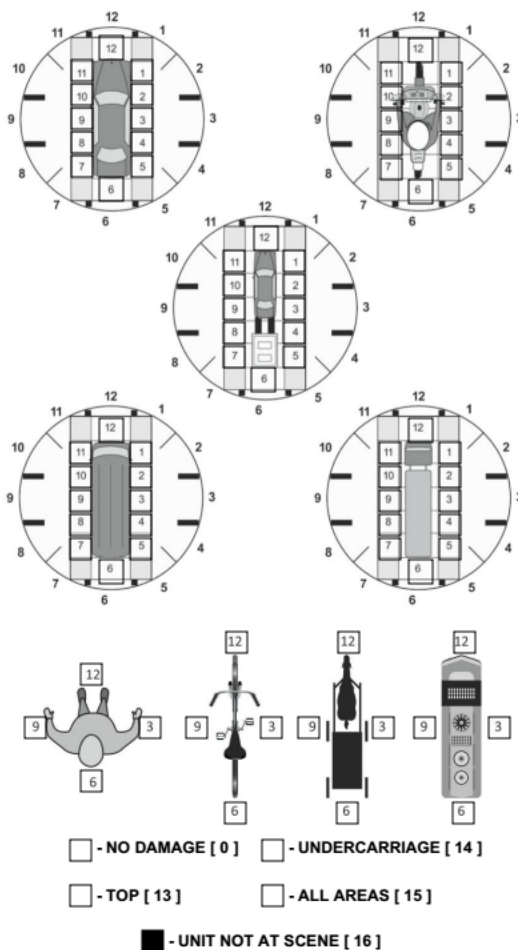

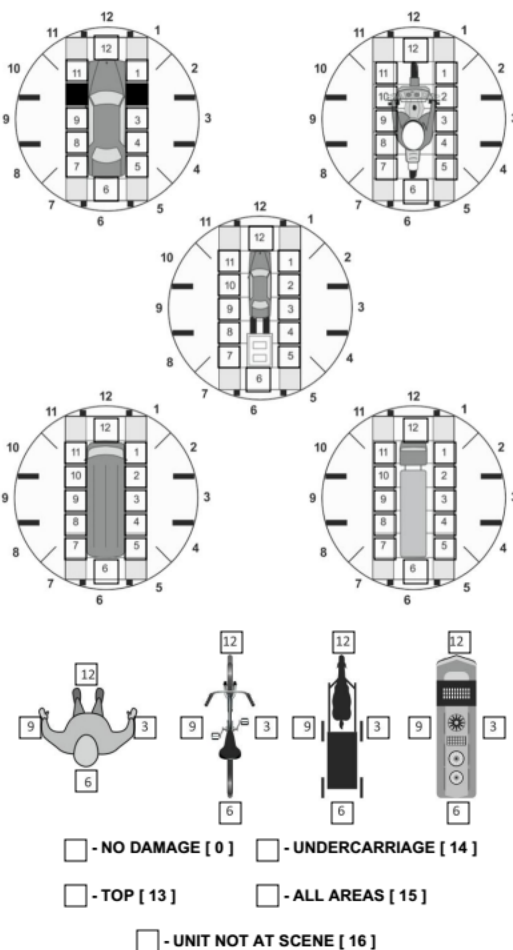

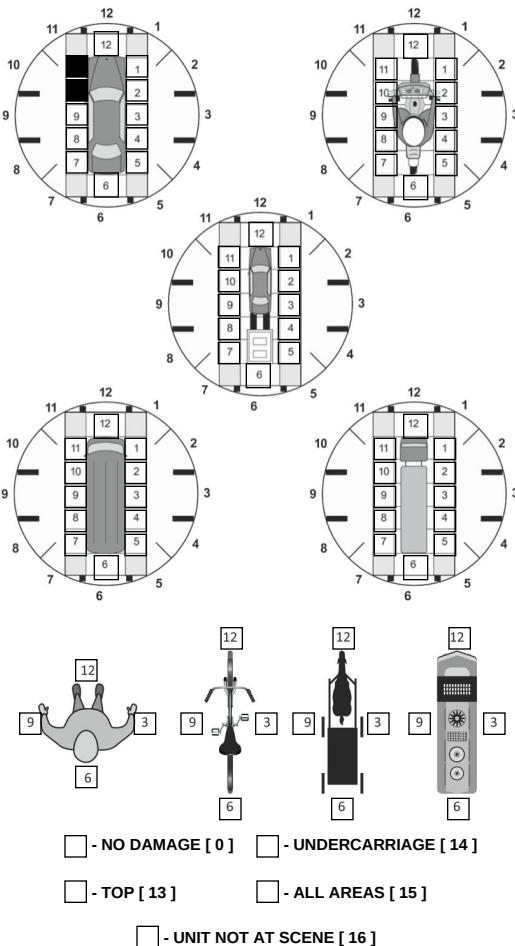
