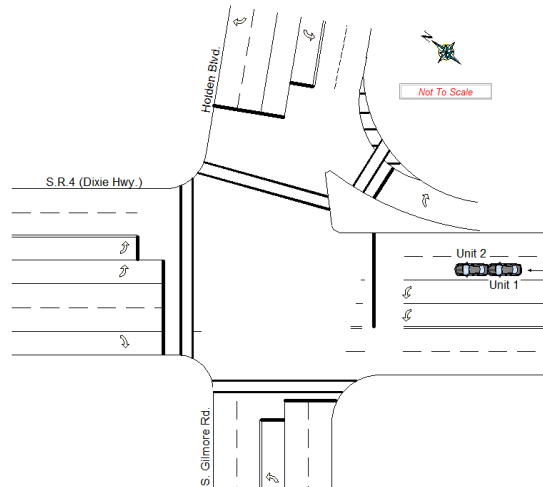

NARRATIVE

Unit 1 struck Unit 2 in the rear.

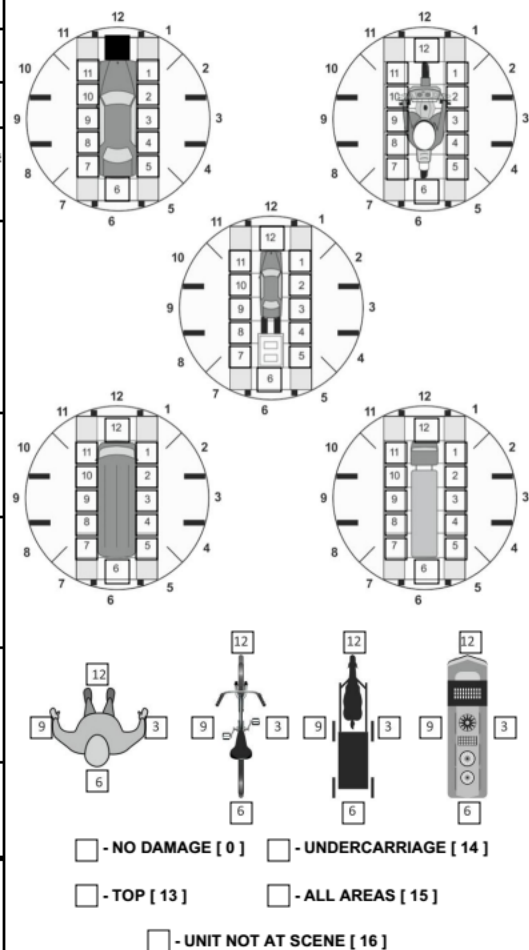

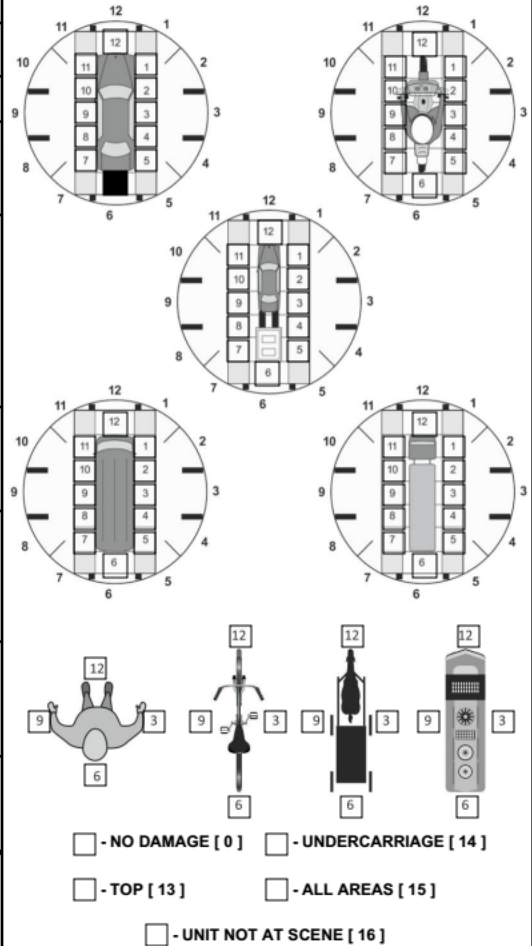
