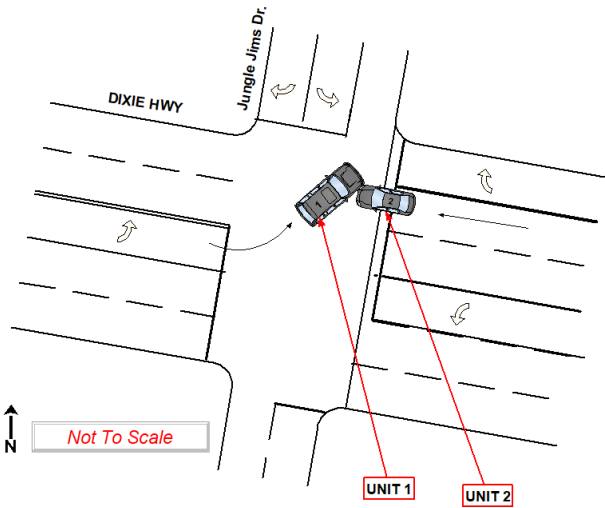

NARRATIVE On 9/20/24 at approximately 5:28 p.m. Unit 2 was traveling northbound on Dixie Hwy at Jungle Jims Dr. when Unit 1 who was traveling southbound on Dixie Hwy made a left turn onto Jungle Jims Dr. failing to yield to oncoming traffic causing Unit 2 to strike Unit 1. Unit 1 left the scene of the accident without exchanging any personal information. Unit 1 was able to be identified by Unit 2 capturing their license plate and could be located utilizing our Flock cameras. Unit 1 hit on Flock near the time of the accident. On 10/1/24 at approximately 4:21 p.m. the hitskip vehicle, Ohio registration ZEPEDA, hit on Flock NB at Dixie and Whitmore at 4:11 p.m. The vehicle was located at 4760 Dixie Hwy. Unit 1 admitted to the crash and was issued a citation for No Drivers License, Right of Way at Intersections and Fleeing the scene of an accident (FCO 335.01a1, FCO 331.16a and FCO 335.12). 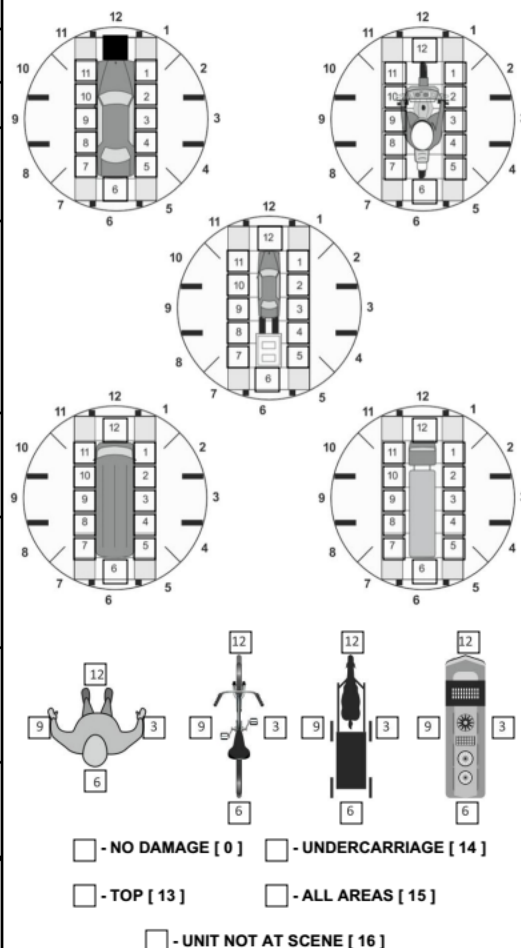
