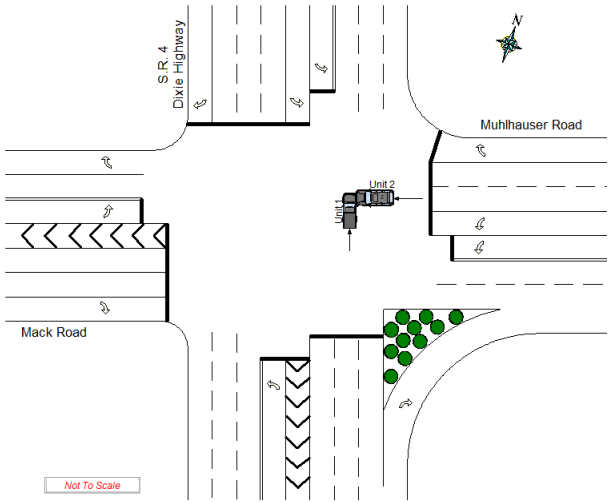

Unit 1 was struck by Unit 2 as Unit 2 was traveling west across the intersection of S.R. 4 and Muhlhauser Rd. The driver of Unit 2 stated he stopped at the stop bar of Muhlhauser Rd. as the traffic lights were dark. The driver of Unit 2 had a temporary permit with no licensed driver in the car. He was cited with FCO 335.02a2B. The driver of Unit 1 stated that he was unaware of the light and was following along with traffic. Neither vehicle was cited for the crash.

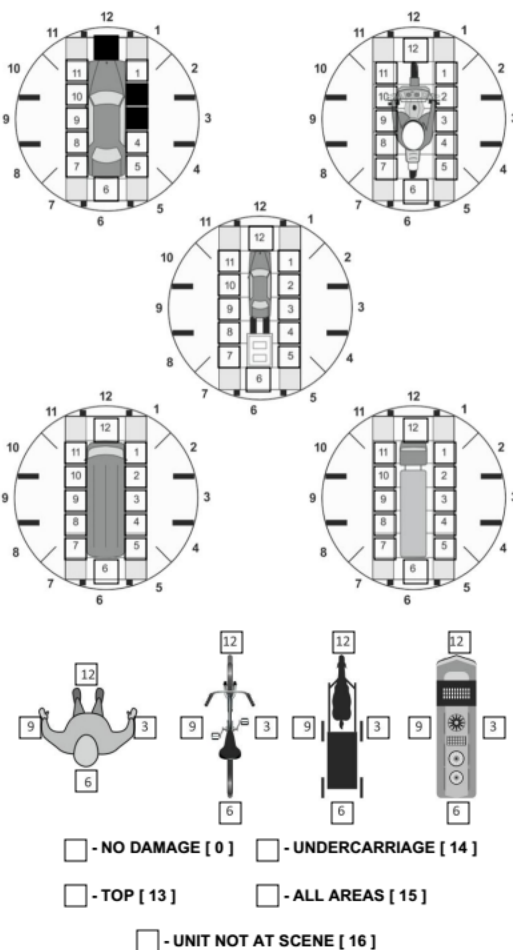
