At the time, the traffic signal was not functioning. Unit 2 then began traveling through northeast through the intersection. At the same time, Unit 1 was traveling northwest on Dixie Hw./SR 4 in the center through lane and when at the intersection of Dixie Hw./SR 4 and Mack Rd./Muhlhauser Rd., failed to stop at the stop bar prior to entering the intersection. 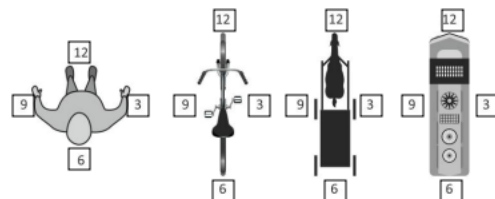
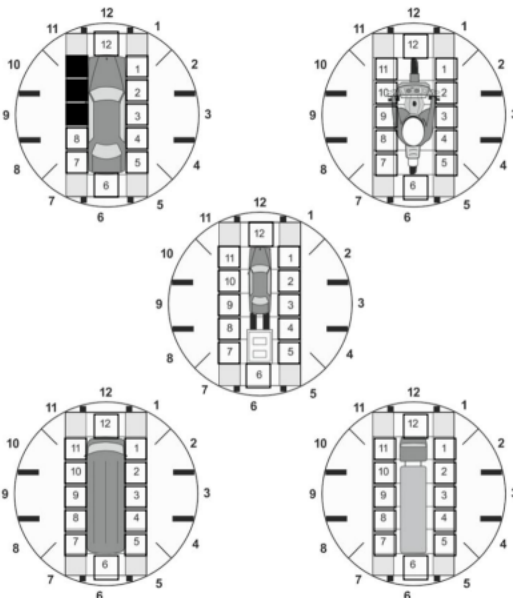

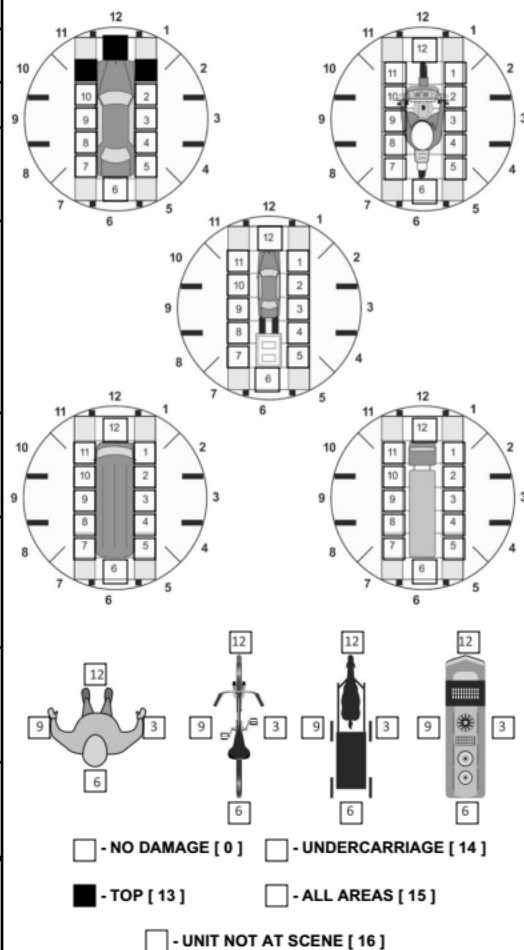
