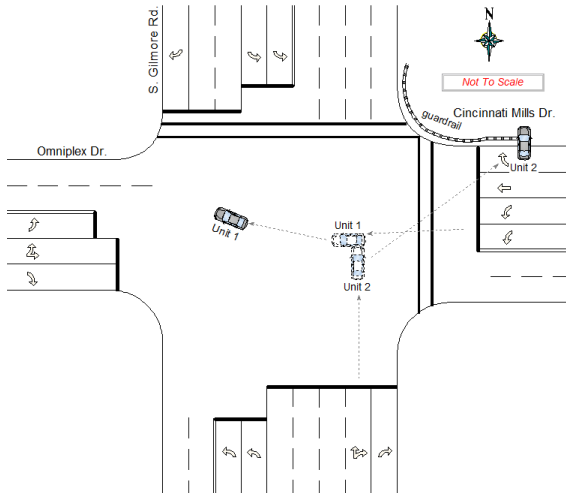

NARRATIVE On December 29, 2024 at about 12:09 a.m. Unit 1 was traveling westbound on Cincinnati Mills Dr. (private road), exiting the mall parking lot. The driver of Unit 1 advised the westbound traffic light was red and when she attempted to stop, her brakes failed, causing the Toyota to slide into the intersection. Unit 1 slid into the path of a northbound Unit 2 and was struck. The northbound traffic had the right-of-way. The driver of Unit 1 was unable to stop, or exercise reasonable control over her car, so she was issued a citation for Failure To Control (331.34A). Unit 1 did not provide proof of insurance. The driver of Unit 2 had a Non-Compliance Suspension and two open License Forfeitures, so he was issued a citation for Driving Under Suspension (#2400282853). 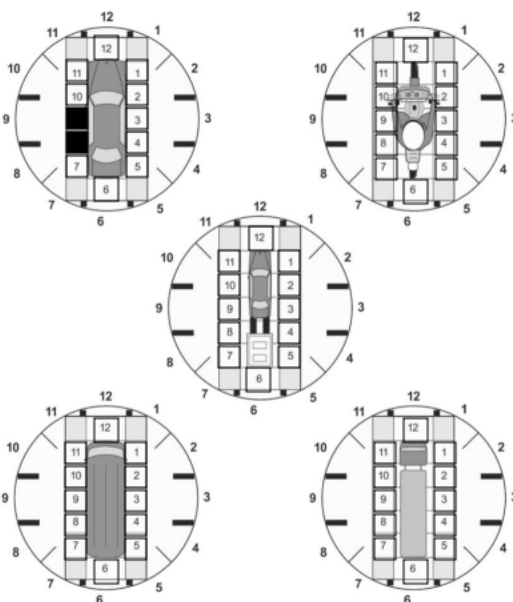

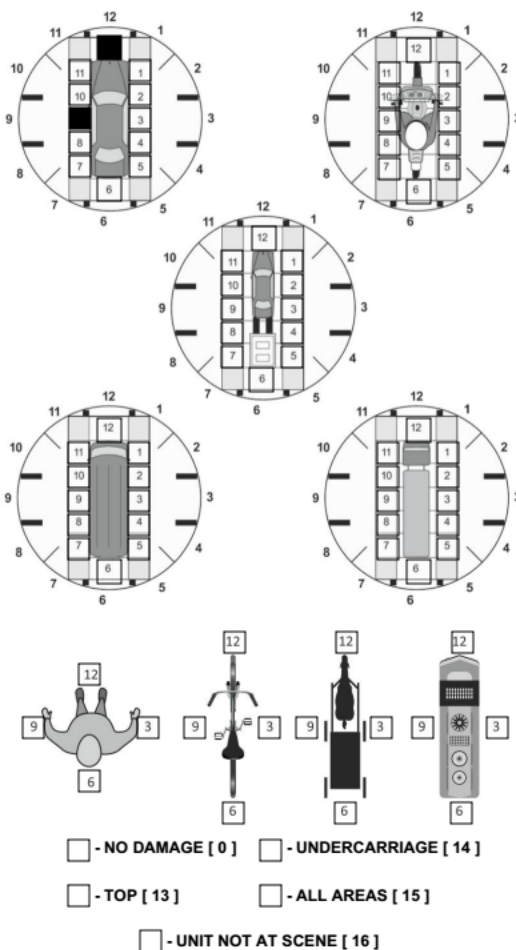
