

NARRATIVE On October 4, 2024 at 4:57 p.m., Unit 1 was traveling north on South Gilmore Road, followed by a witness. Unit 1 was described by the witness as making multiple marked lanes violations. Unit 1 driver then went off the roadway to the right, onto the curb, then struck a utility pole head on. The vehicle then continued back onto the roadway, crossing all lanes of travel and came to rest against the curb in the southbound lanes. The utility pole was severed in half which caused power outages in the area. Unit 2 which was stopped at the intersection of Ridge Rd and South Gilmore had the utility wires fall on his truck when the pole was severed. 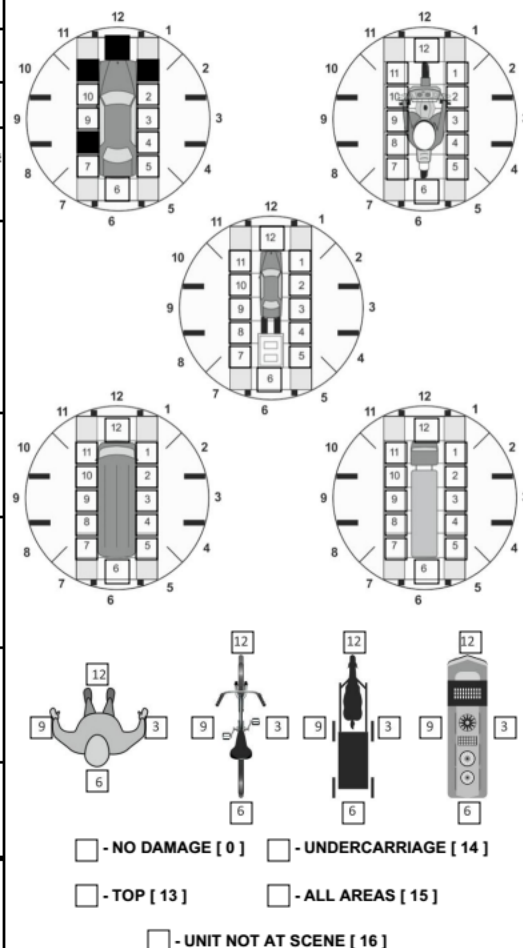
