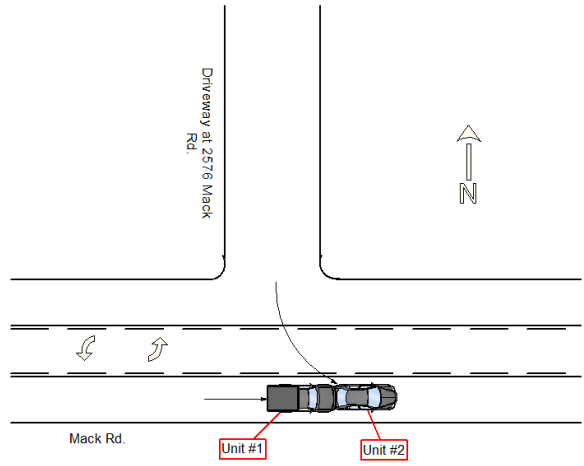

The driver of unit #2 stated that he observed unit #1 and felt he had plenty of time to make the turn onto Mack Rd. in front of unit #1, but was struck immediately after making the turn onto the roadway.

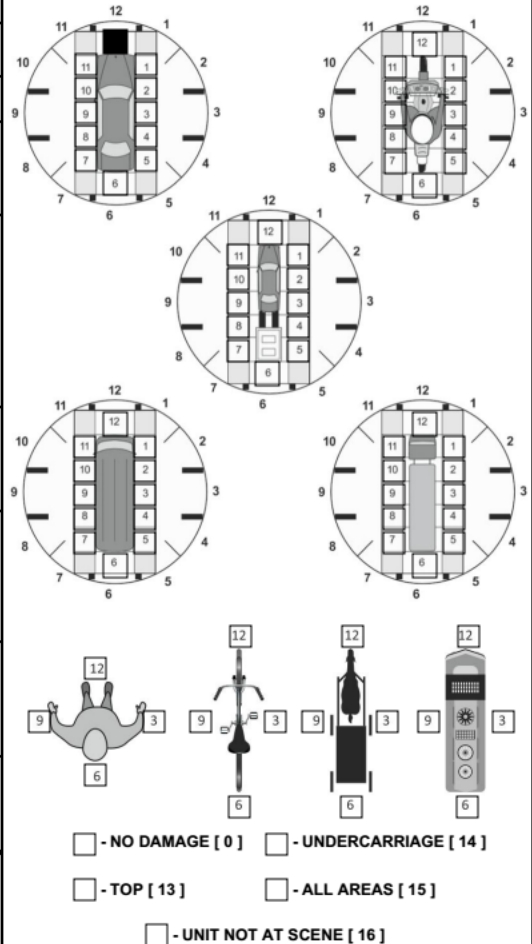
