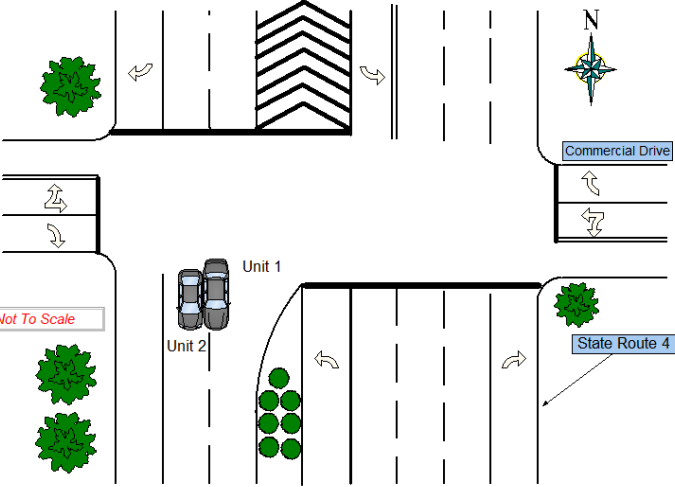

Unit 1 was traveling south on Dixie Hwy as well, occupying the inside lane at the time. Unit 1 failed to maintain its lane of travel and sideswiped Unit 2 while overtaking it. The driver of Unit 1 failed to stop after the crash, but was later located and identified. He was also charged with Leaving the Scene and No OL. The driver of Unit 1 did not have insurance. 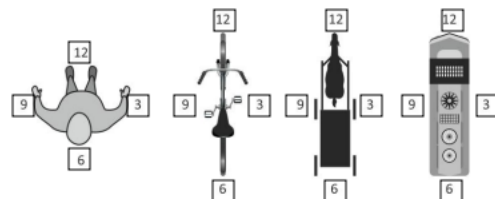
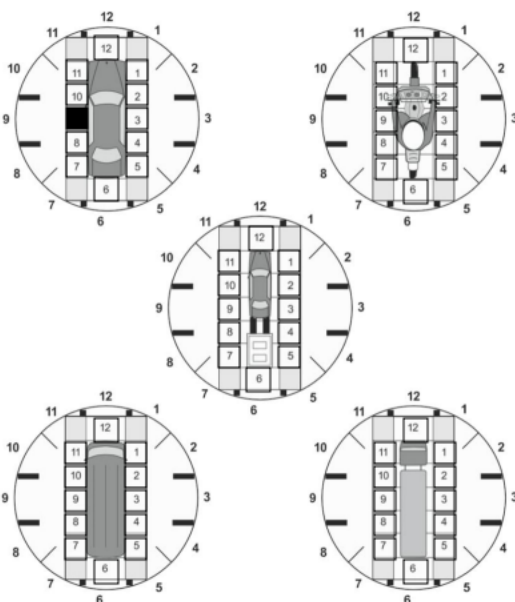
