NARRATIVE On November 3, 2024 at approximately 2:50 p.m. Unit 1 and 2 were traveling east on Port Union Rd. and at a private drive 300 ft. east of Holden Blvd. Unit 2 stated that Unit 1 exited the roadway and entered the private drive, and then attempted to re-enter the roadway, striking Unit 1 on the passenger's side. The driver of Unit 1 stated that Unit 2 was behind him when Unit 2 went left of center to overtake Unit 1 striking it on the front driver's side corner. 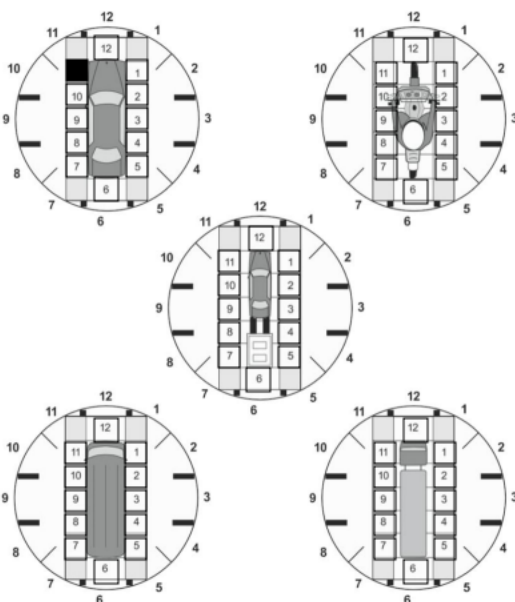

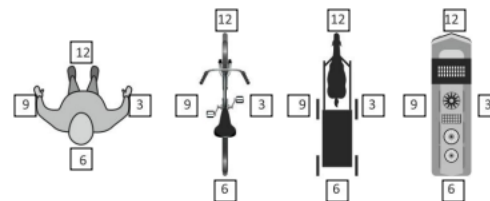
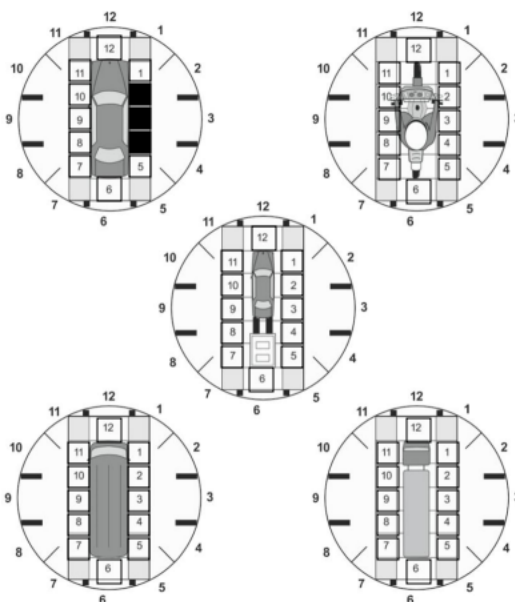
