NARRATIVE On 11-19-24 at 11:55 a.m., Unit 1 and Unit 2 were traveling south on SR4 (Dixie Hwy) in the left through lane. Unit 3 and Unit 5 were stopped in traffic southbound on SR4 (Dixie Hwy) in the center through lane. Unit 4 and Unit 6 were stopped in traffic in the left through lane. Unit 1 struck Unit 2 in the rear pushing it into the right hand left turn lane. Unit 1 then drove forward and struck the driver side of Unit 3, the passenger side of Unit 4 and then struck the driver side of Unit 5. After Unit 4 was struck, Unit 4 struck the rear trailer of Unit 6. Unit 1 was pulling an unregistered trailer Unit 3 was pulling a trailer boat trailer (IN:TR492YXW) with a 2020 Centurion boat. The boat was damaged by flying debris in the front hull. Unit 6 was pulling a semi tailer (MI:D548966) The driver and passenger of Unit 1 left the scene before police arrived, after parking Unit 1 in the lot of 7504 Dixie Hwy. 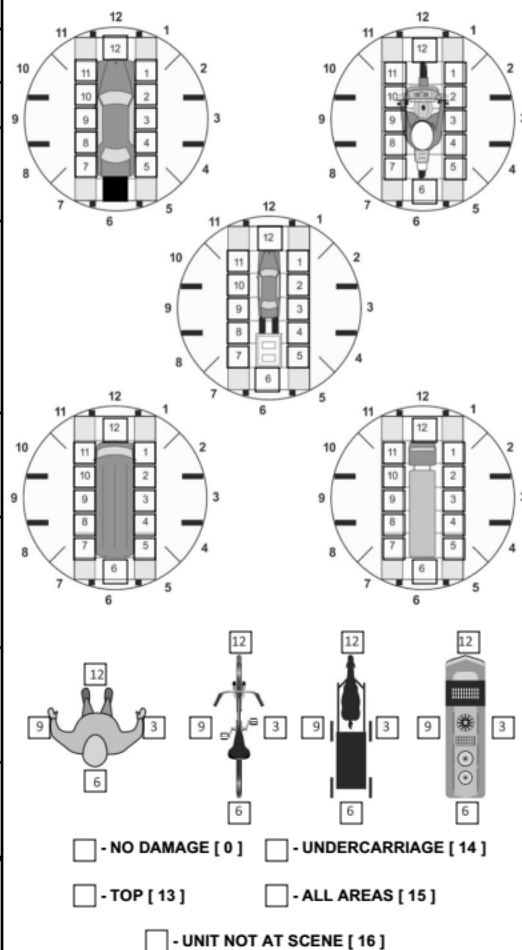
