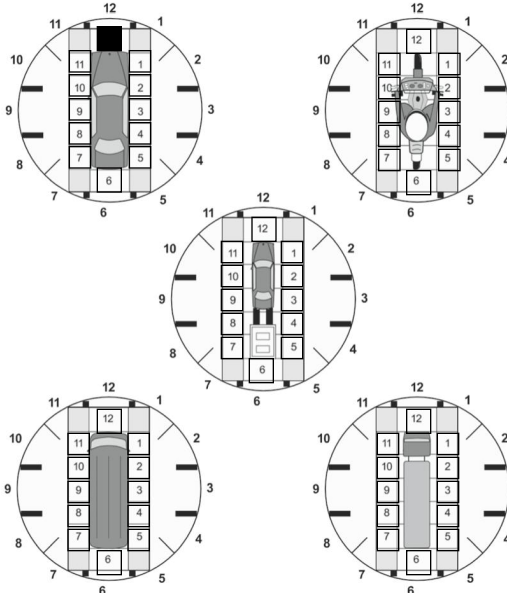
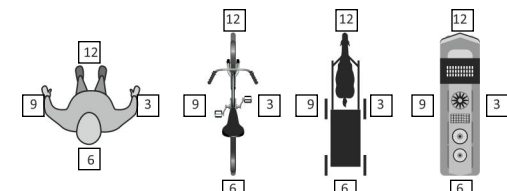

Unit 3 was traveling east on Union Center Blvd behind Unit 2 when Unit 1 and Unit 2 collided. After Unit 1 and Unit 2 collided, unit 2 spun clockwise and Unit 3 struck the right rear of Unit 2 then was struck by Unit 1. The diagram shows the sequence of events from left to right. 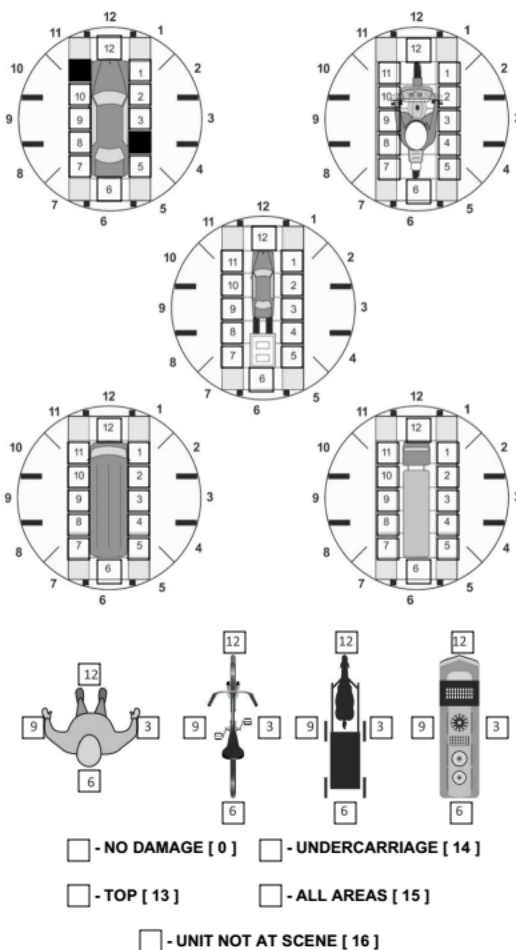

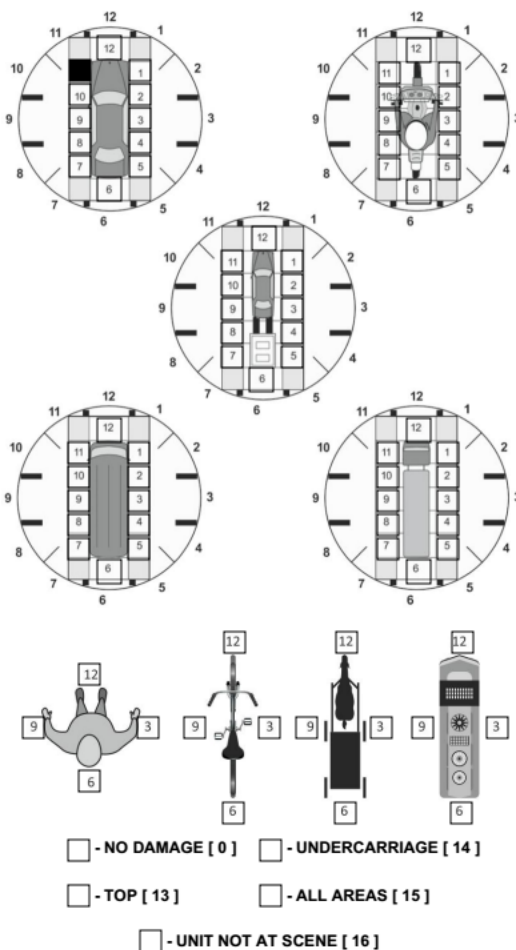
