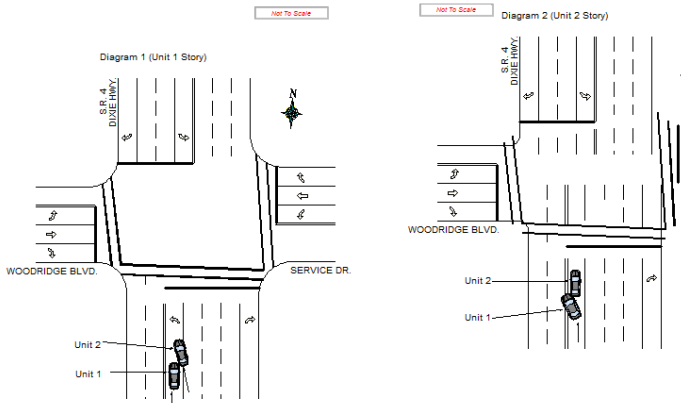

Unit 1 stated they were traveling North on SR-4 and entered the left turn lane to travel West on Woodridge Blvd. Unit 1 stated Unit 2 was traveling in the same direction in the left through lane and made an improper lane change and struck Unit 1 on the front passenger side. The driver of Unit 2 stated they were in the left turn lane on SR-4 to turn West on Woodridge and said Unit 1 was behind him, and went into oncoming traffic, and struck them on the rear driver side. The at fault driver was unable to be determined due to difference of opinion of what had occurred. The driver of Unit 1 failed to stay at the crash. 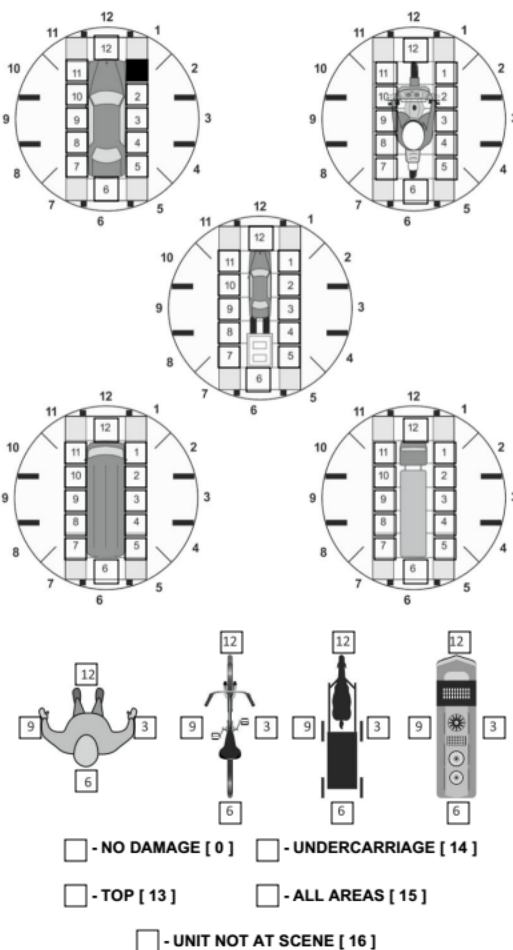

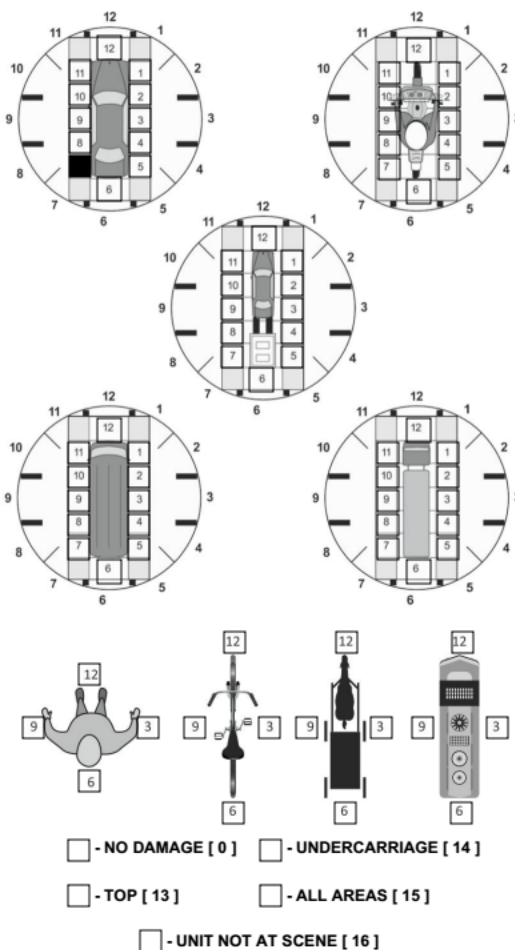
