NARRATIVE On November 13, 2024 at 6:07p.m., Unit 2 was parked unoccupied in the parking lot of 5181 Dixie Highway. Unit 1 backed into a parking spot directly next to unit 2. While parking, Unit 1 got very close to unit 2, rubbing up against it causing damage to the drivers side rear. Unit 2 driver was not aware this occurred until she returned to her vehicle and noticed her Tesla notified her that a vehicle had been very close to her vehicle. She exited her vehicle and saw damage to the drivers side rear. Due to Tesla having 360 degree cameras. The entire incident was caught on camera. Unit 1 driver is seen reversing multiple times to angle his car correctly. He is then seen exiting his vehicle and accessing the damage to Unit 2. He did not make contact with the owner of the vehicle, and did not leave contact information. 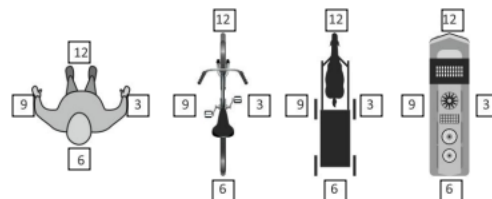
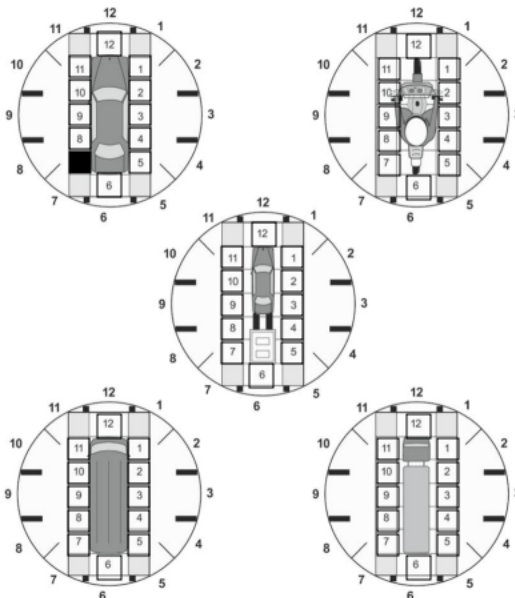
