NARRATIVE Driver of Unit 1 version of crash: On 12/13/24 at 12:46 P.M. The driver of Unit 1 said as he was driving north bound in the inside left lane of SR 4 in front of 7311 Dixie Hwy (SR 4), Unit 2 (who was driving in the left turn lane of south bound SR 4 in front of 7311 Dixie Hwy) crossed the center line of the roadway and struck the drivers door mirror of Unit 2 with the drivers door mirror of Unit 1. Driver of Unit 2 version of crash: On 12/13/24 at 12:46 P.M. The driver of Unit 2 said while traveling in the left turn lane of south bound SR 4 at 7311 Dixie Hwy. (SR 4), Unit 1 which was traveling north bound in the inside left lane of SR 4 (at 7311 Dixie Hwy) crossed the center line of the roadway and struck the drivers door outside mirror of Unit 1 with the drivers door mirror of Unit 1. 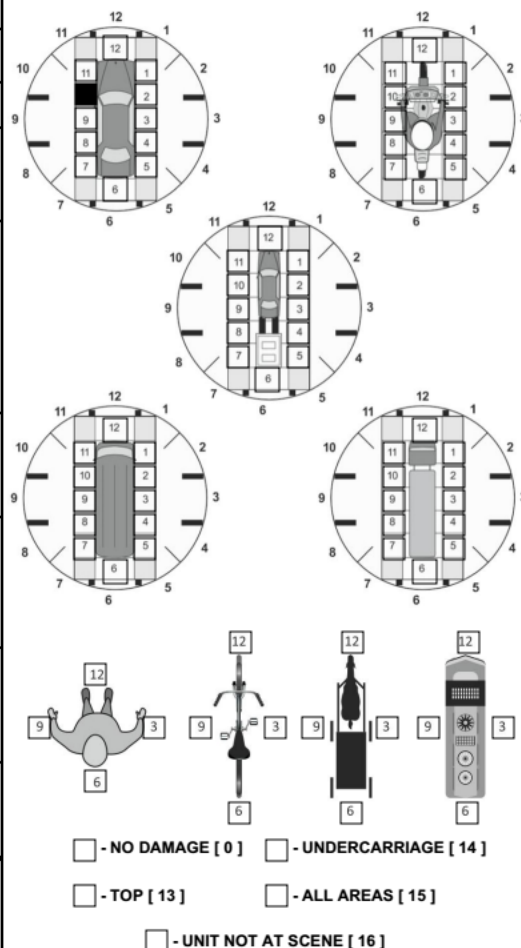

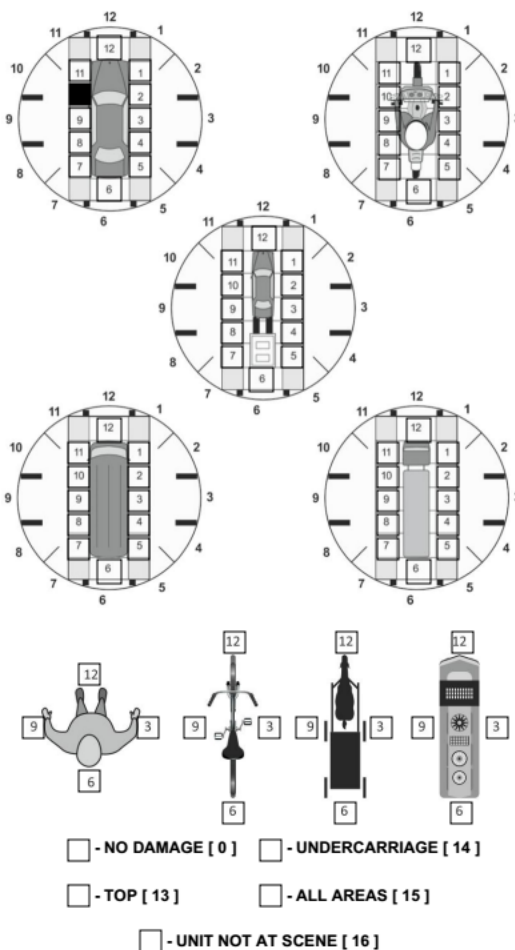
