NARRATIVE On December 16, 2024 around 11:16 p.m. Unit 1 was traveling southbound on Camelot Drive. Unit 1 failed to maintain control, went off the right side of the roadway, and struck a fire hydrant, shearing it off. The fire hydrant is owned by City of Fairfield (5350 Pleasant Ave, Fairfield, OH 45014). The fire hydrant was sheared off down to the main, causing a large amount of water to flow, and a large section of roadway to flood. The Fairfield Water Department had to be called for an emergency repair, water was shut off to the surrounding area, and the southbound side of the roadway remained closed during repair. The driver of Unit 1 was issued a citation for Failure to Control (331.34a F.C.O.) and Driver's License Required (335.01a1 F.C.O.).				DIAGRAM

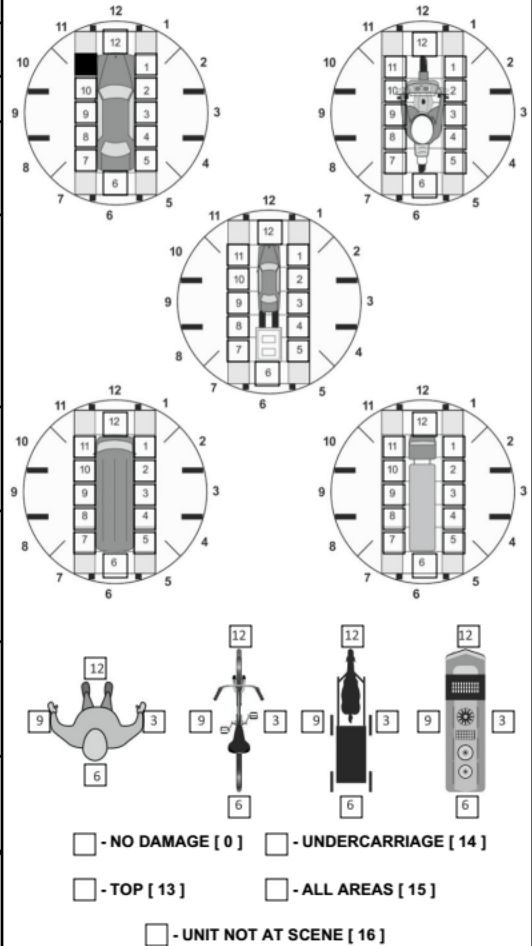
