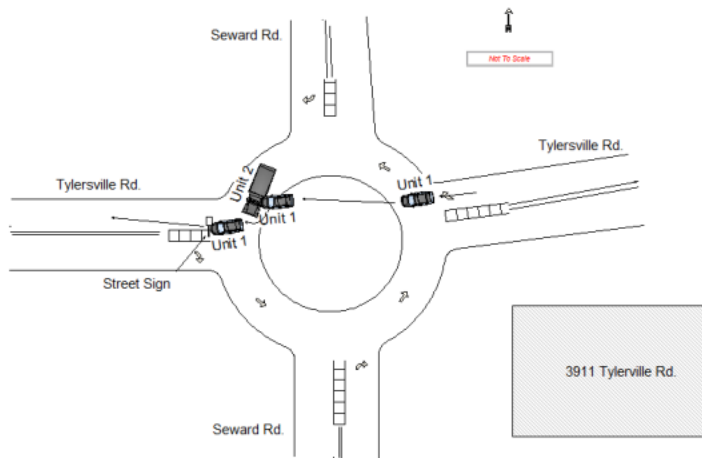
NARRATIVE

On 12/17/24 at 2:05 P.M. Unit 1 was traveling West on Tylersville Rd. and when at the Seward Rd. roundabout, drove off the roadway into a rock pit in the median. Unit 1 then continued back onto the roadway striking Unit 2 while they were in the roundabout to go South on Seward Rd. Unit 1 continued on and struck a street sign, and left the scene westbound on Tylersville Rd.

The driver of Unit 1 was also charged with OVI FCO 333.01 a1 M-1, OVI over limits FCO 333.01 a1H M-1, and leaving the scene of a crash FCO 335.12 a M-1

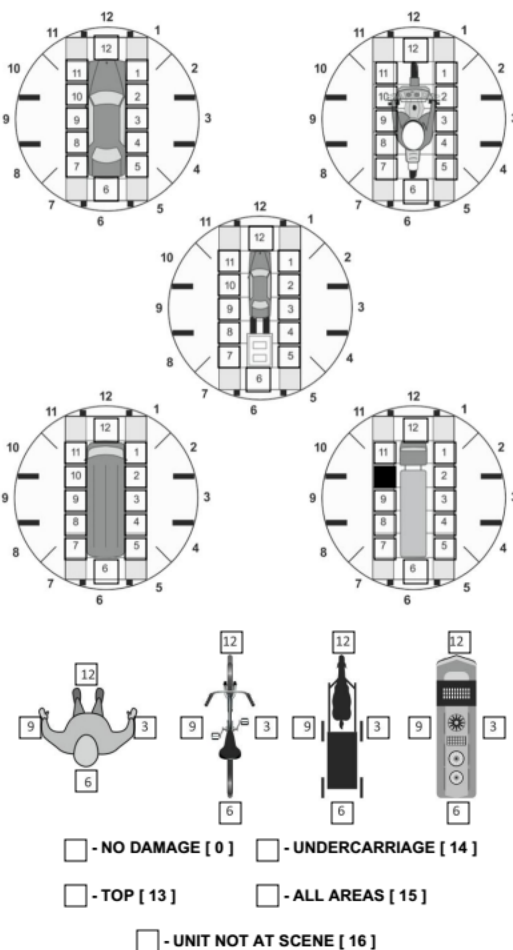
