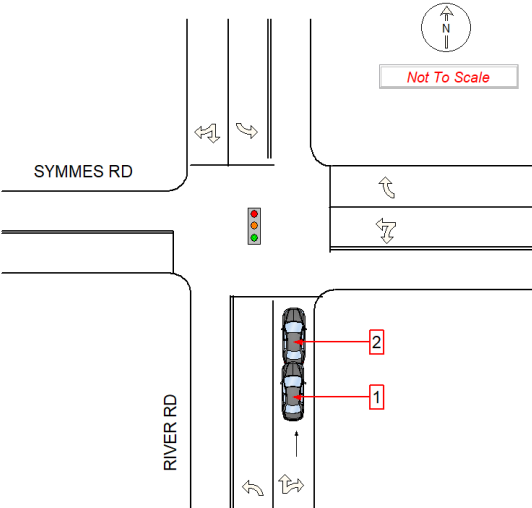

Unit 1 fled the scene without exchanging information or waiting for police to arrive. 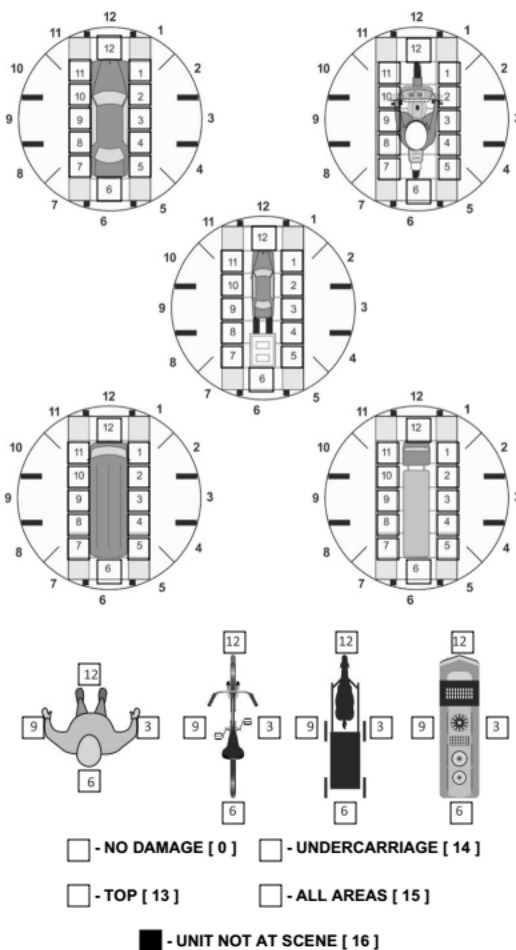

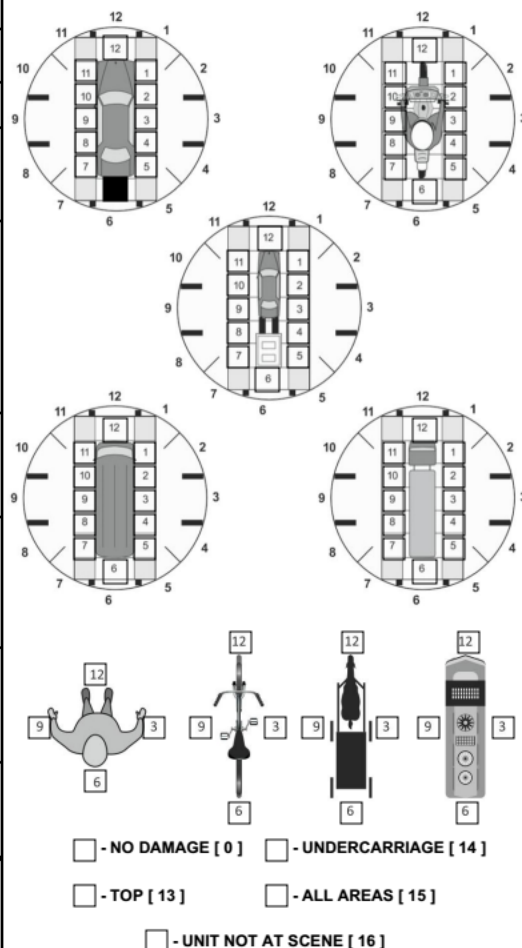
