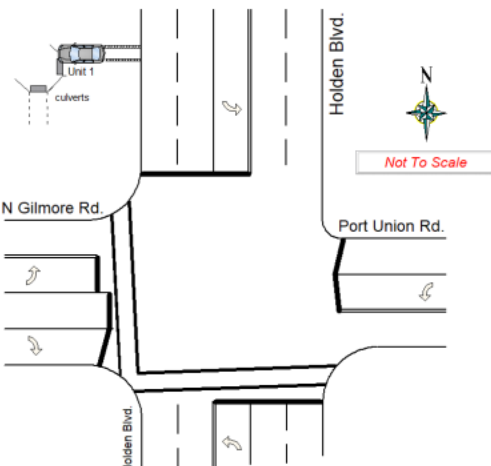

Unit 1 was located unoccupied off the west side of Holden Blvd., in a ditch, and resting on a cement culvert. The grass was disturbed, but the cement culvert appeared undamaged. The driver of Unit 1 left the scene without stopping to exchange information, or to contact the Fairfield Police to report the accident. The grass and cement culvert are owned by the City of Fairfield (5350 Pleasant Ave, Fairfield, OH 45014)

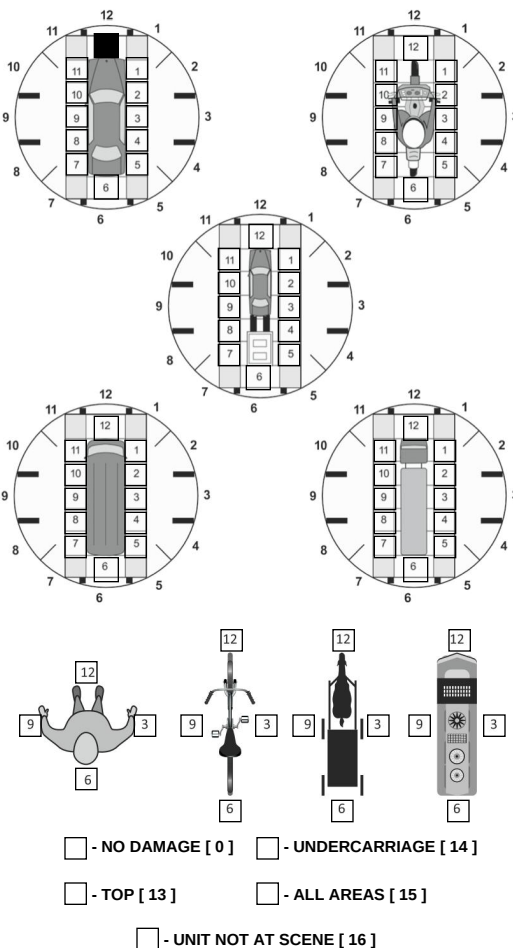
