NARRATIVE On 08-06-23 at about 7:07 PM units #1, #2 & #3 were southbound on Dixie Hwy. in the area of 4865 Dixie Hwy. This section of roadway has two southbound lanes as well as a center turn lane. The three units collided however none of the parties agreed on how the crash occurred but the damage on the vehicles was consistent with each story. No drivers were cited since a violation could not be clearly established. The driver of unit #1 stated he was slowing and merging into the center turn lane to make a left turn when unit #2 attempted to pass him in the center turn lane, striking him in the process. Unit #3 then struck him. The driver of unit #2 stated she was traveling in the left through lane when unit #1 made a left turn from the right through lane striking her. The driver of unit #3 was not clear on what occurred only saying that units #1 & #2 crashed in front of her causing unit #1 and her to collide. 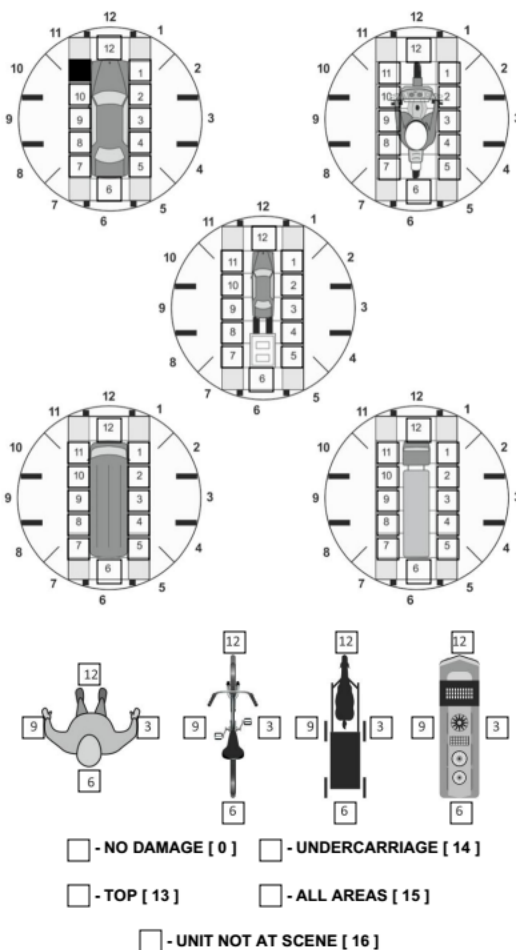

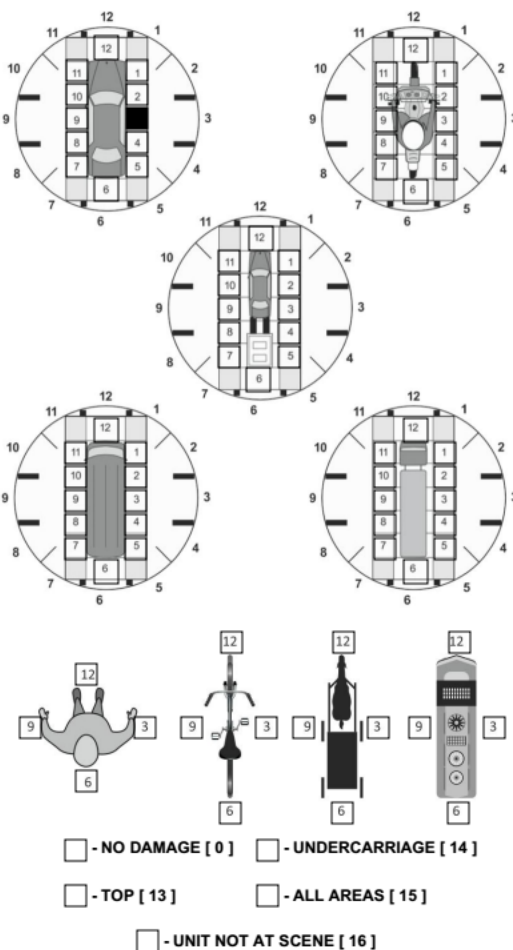

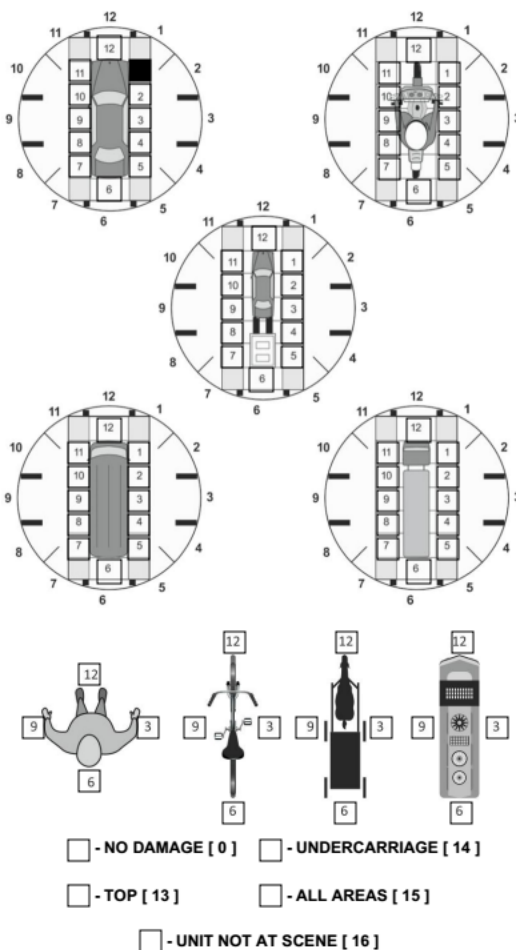
