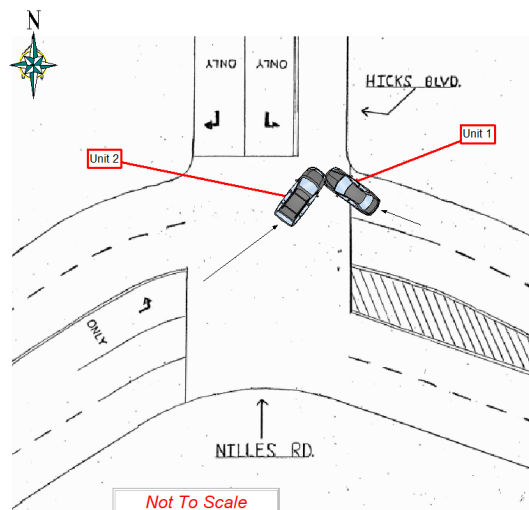
NARRATIVE

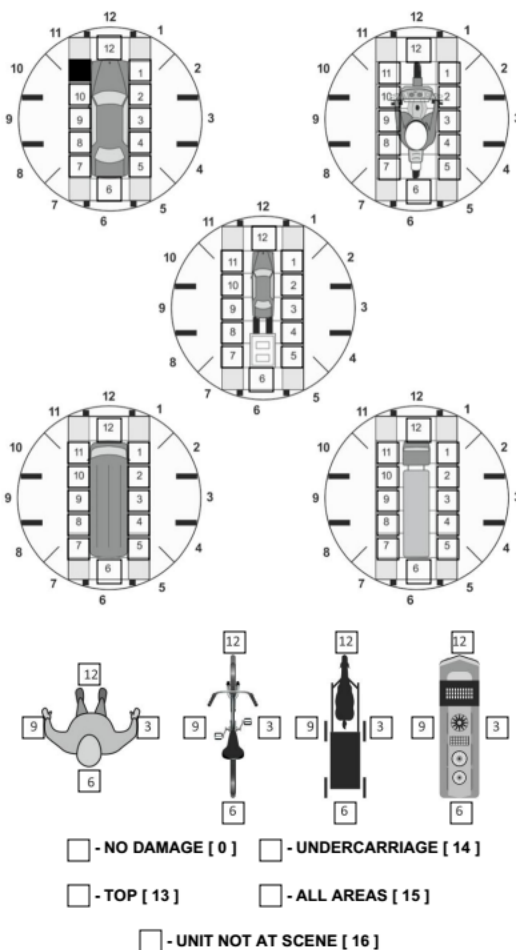

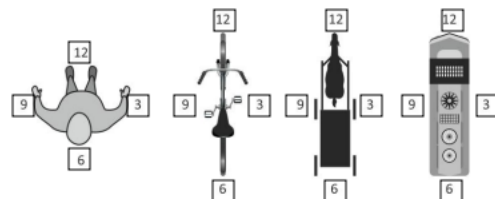
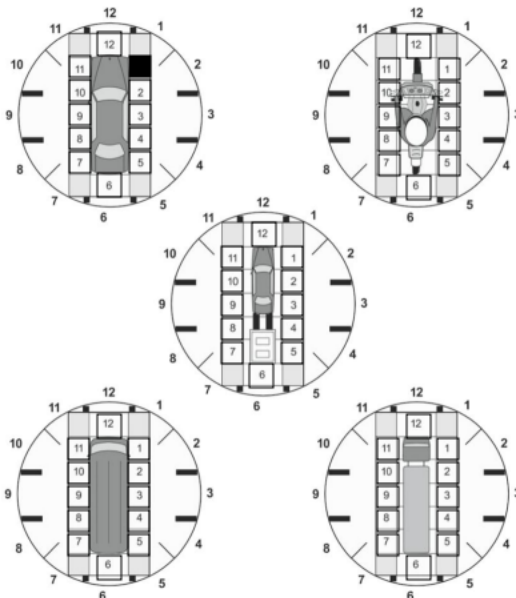
