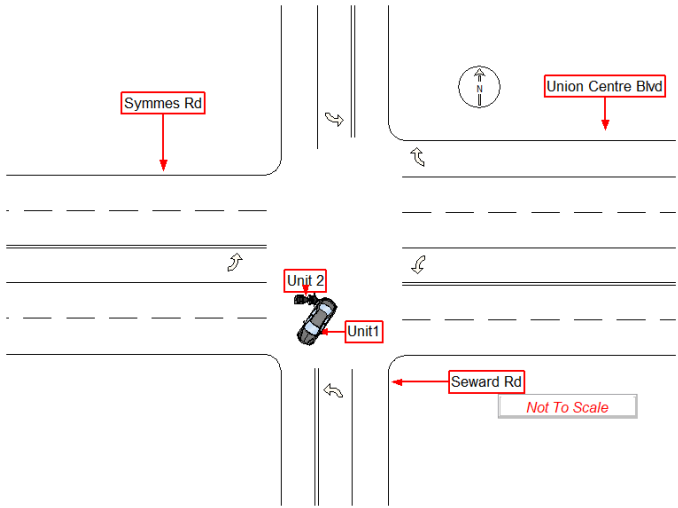

Unit 1 attempted to turn left onto Seward Rd and stopped in the middle of the intersection causing Unit 2 to strike the passenger side rear of Unit 1. 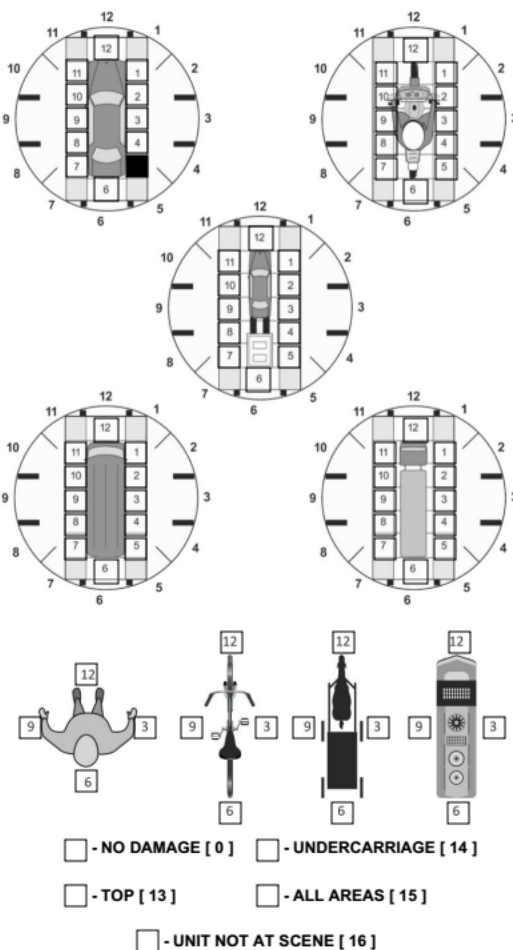

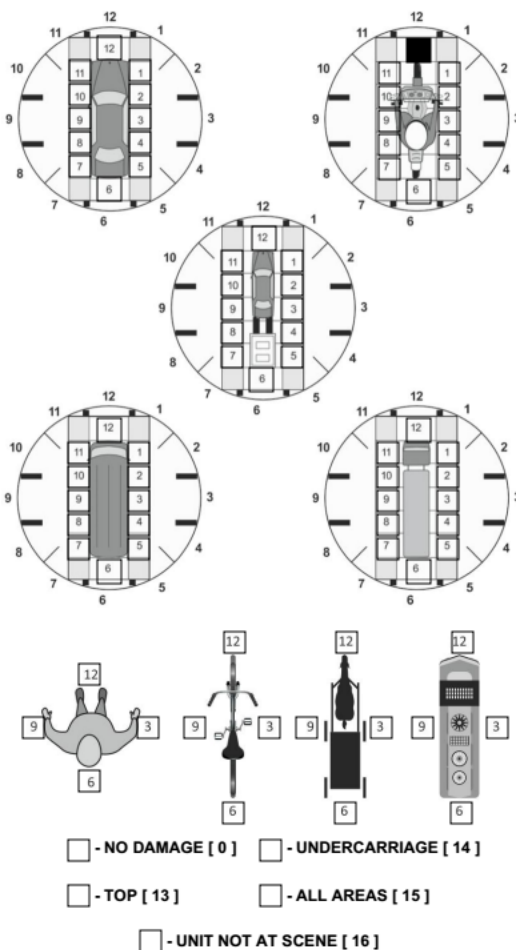
