NARRATIVE On 07-19-23 at about 4:25 PM Unit #2 was eastbound on Nilles Rd. and entered the intersection of Pleasant Ave. on a green light to turn left onto Pleasant Ave. However, unit #2 was not immediately able to make the turn because of oncoming traffic. By the time it was safe for unit #2 to make the turn the light had turned red. Unit #2 made its turn at this time. Unit #1 was stopped at a red light, southbound on Pleasant Ave. making a left turn onto Nilles Rd. Once unit #1's light changed to a green arrow it began to make its turn. Unit #1 struck unit #2. 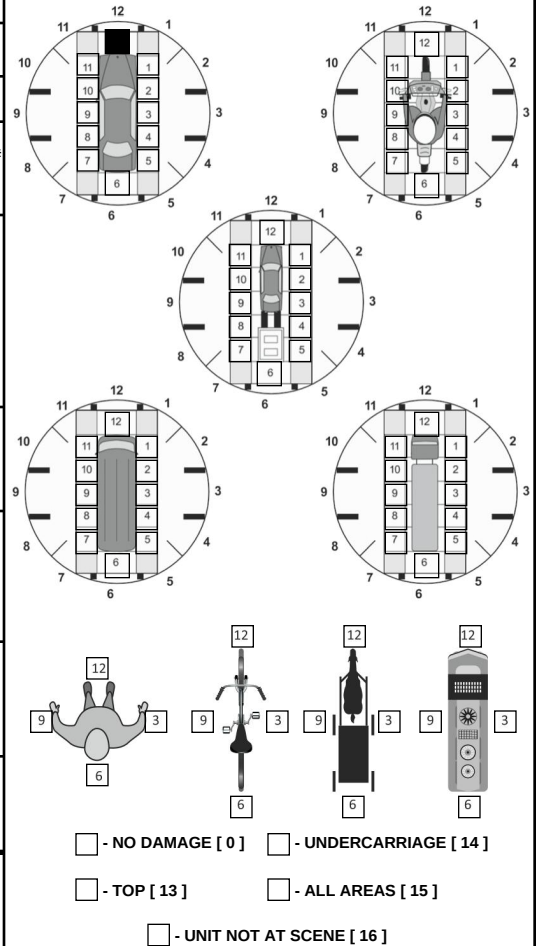
