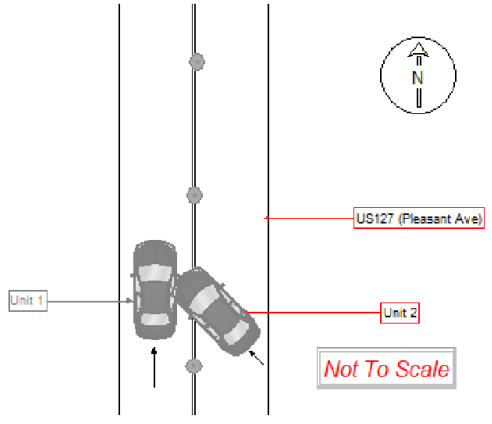

Unit 1 went into the southbound lanes to go around the construction people setting up the cones. Unit 2 also attempted to go into the southbound lanes to go around the construction people but did not see Unit 1 already was in the southbound lane and struck Unit 1 in the passenger side door. 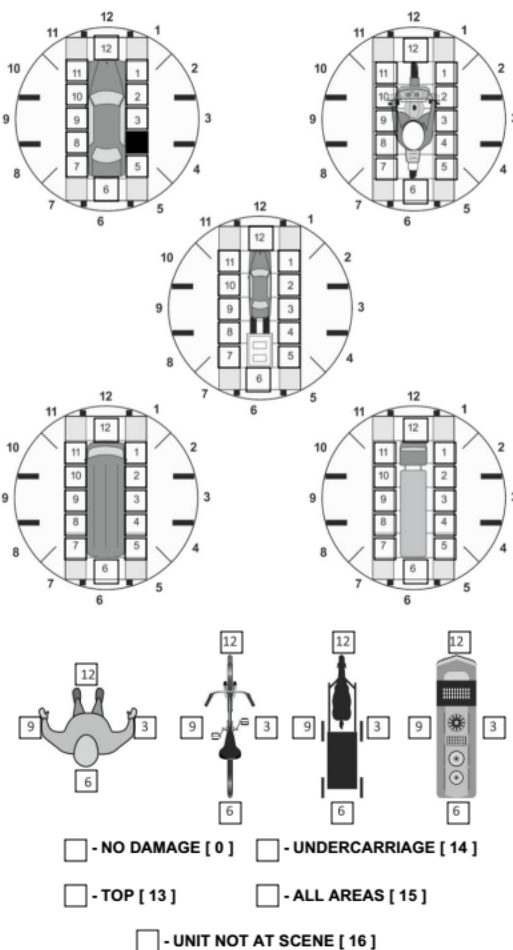

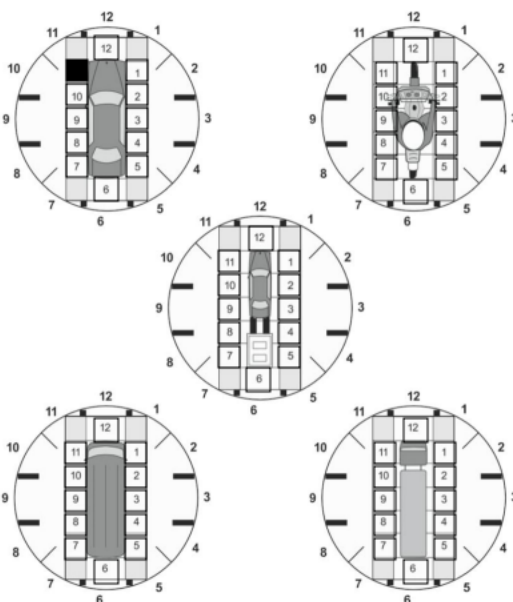
