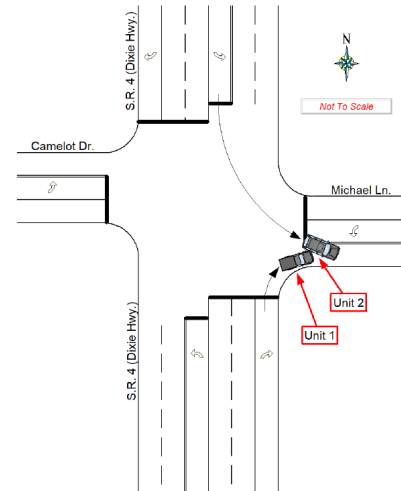
Unit 1 Version

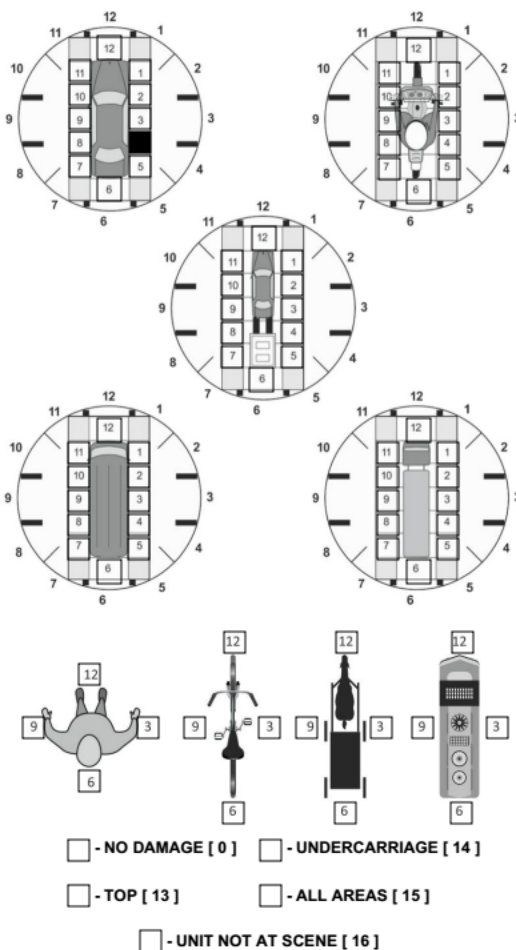
