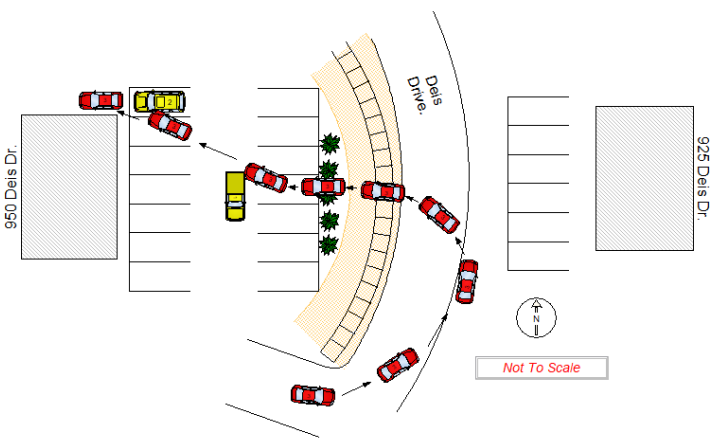

NARRATIVE On October 10, 2023, at 4:11 p.m., unit 3 was leaving Telhio Bank. Unit 3 accelerated leaving the parking lot, driving up onto the curb in front of The Urology Group, entering back in the roadway. Crossing the opposite lane of travel, driving up onto the curb in front of Telhio Bank, driving across the bushline, back into the parking lot of Telhio where she struck unit 1, then struck unit 2 which caused unit 3 to become disabled. Unit 3 stated the vehicle accelerated and the breaks would not work.

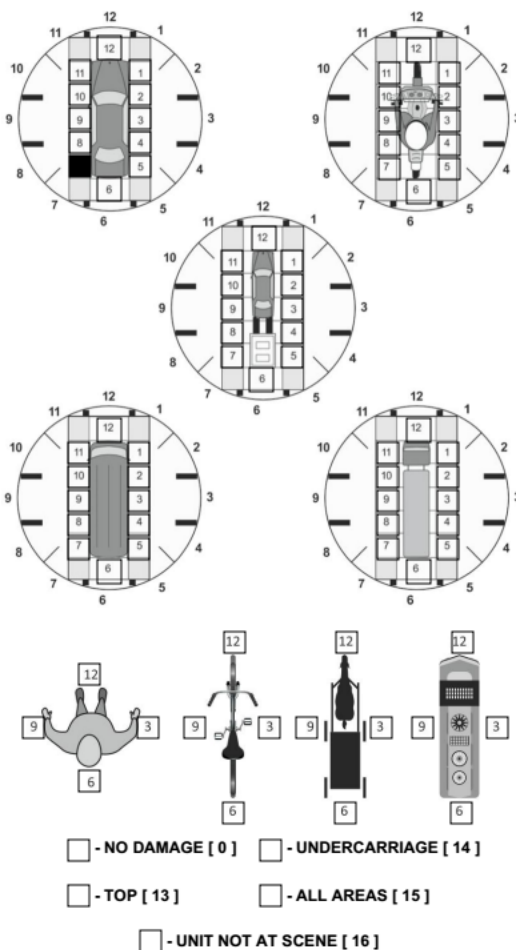

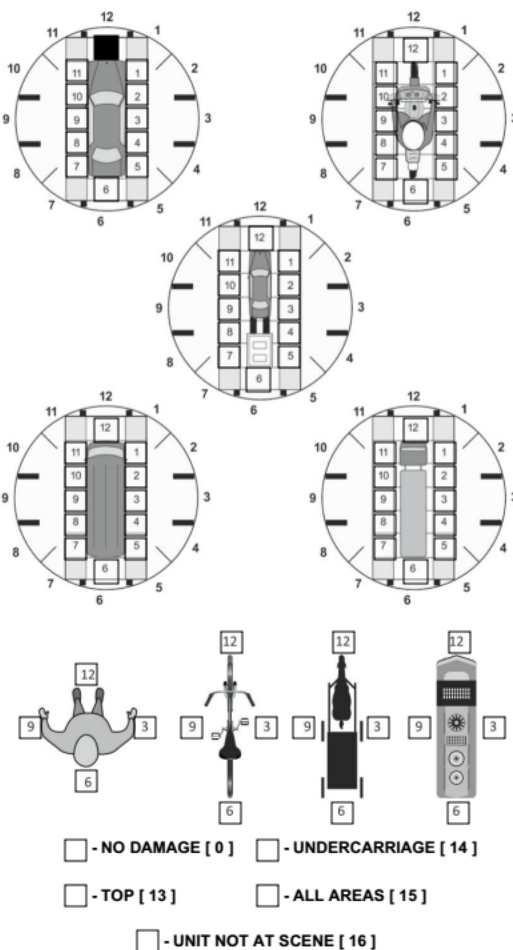
