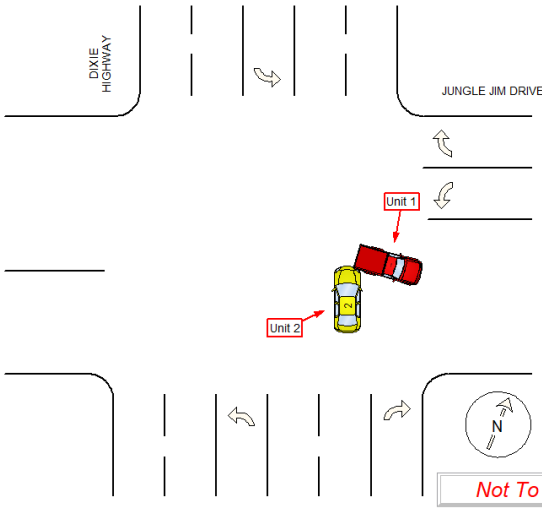

NARRATIVE ON OCTOBER 1, 2023 AT 4:53 UNIT 2 WAS TRAVELING NORTH ON DIXIE HIGHWAY. UNIT 1 WAS MAKING A LEFT TURN ONTO JUNGLE JIM DRIVE FROM NORTH BOUND DIXIE HIGHWAY. UNIT 1 DID NOT YIELD TO ONCOMING TRAFFIC WHEN MAKING THE TURN, CAUSING UNIT 2 TO STRIKE UNIT 1. UNIT 1 LEFT DIRECTLY AFTER THE ACCIDENT AND WENT AND PARKED NEAR THE TREE LINE IN JUNGLE JIMS PARKING LOT. UNIT 1 DID NOT CHECK TO SEE IF UNIT 2 WAS OKAY, NOR DID HE CALL THE POLICE. 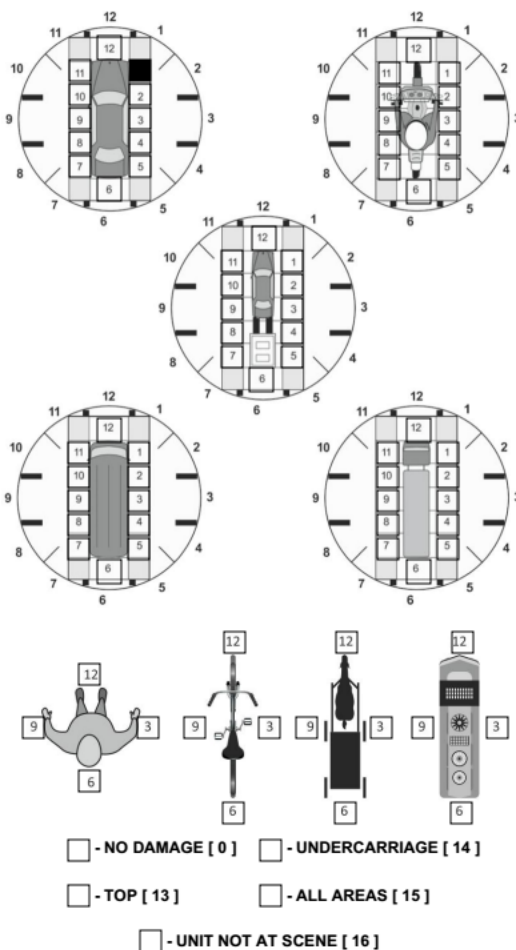
