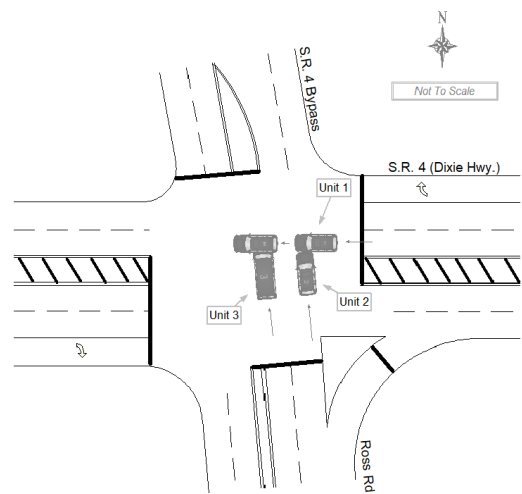

NARRATIVE

On September 29, 2023 at approximately 5:30 PM, Unit 1 was traveling northwest on Dixie Highway approaching Bypass 4. Units 2 and 3 were traveling northbound on Ross Road approaching Dixie Highway and were stopped at the red light. When the light turned green, Units 2 and 3 proceeded into the intersection to travel straight onto Bypass 4. Unit 1 then ran the red light, was truck by Unit 2, then was struck by Unit 3.

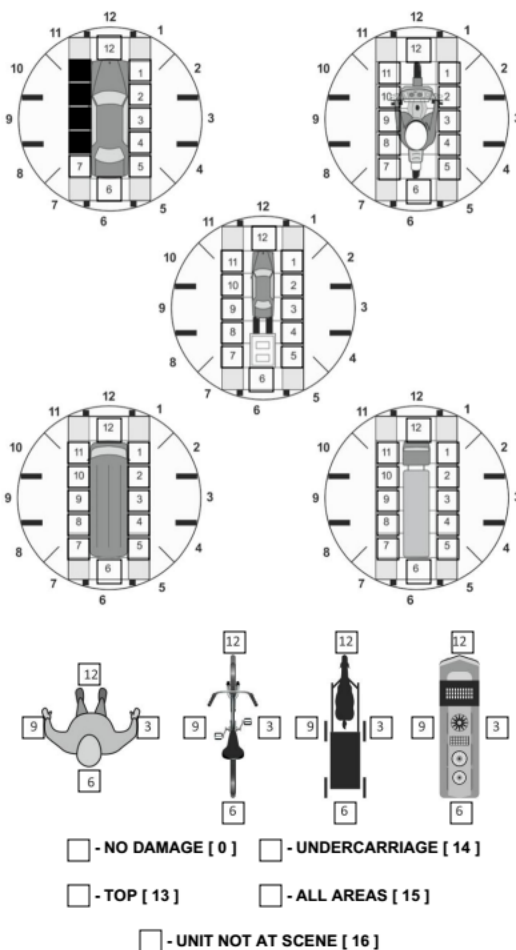

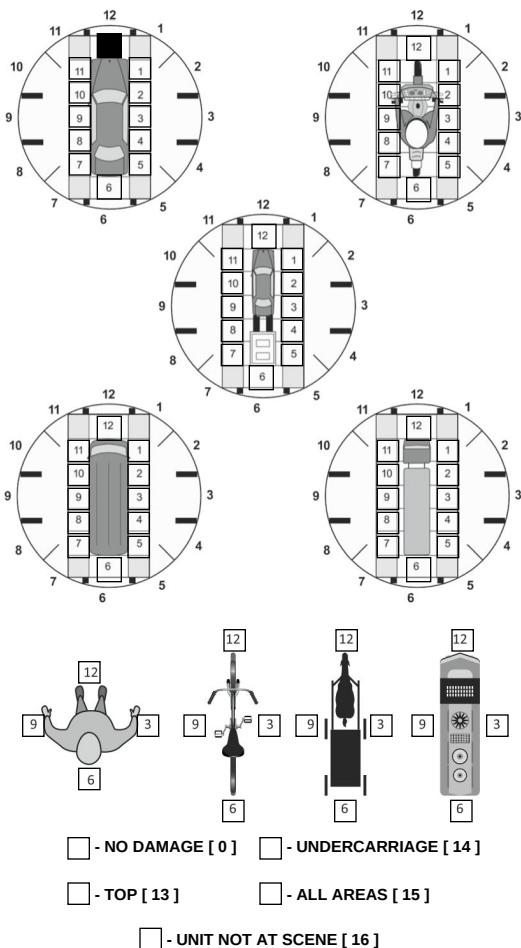

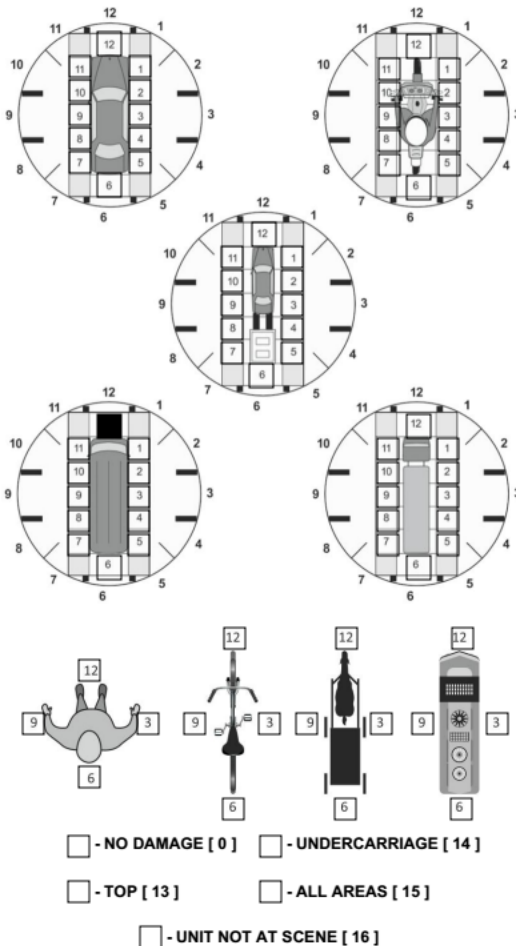
