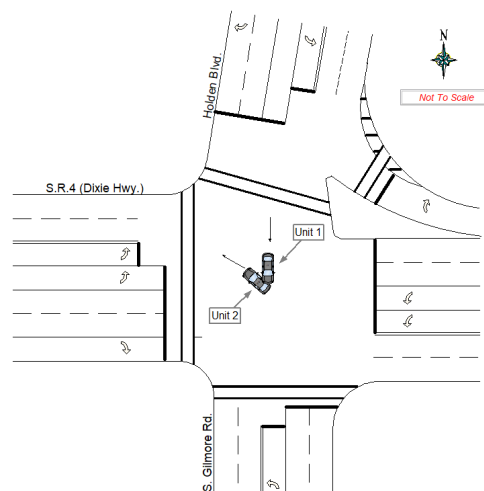

NARRATIVE

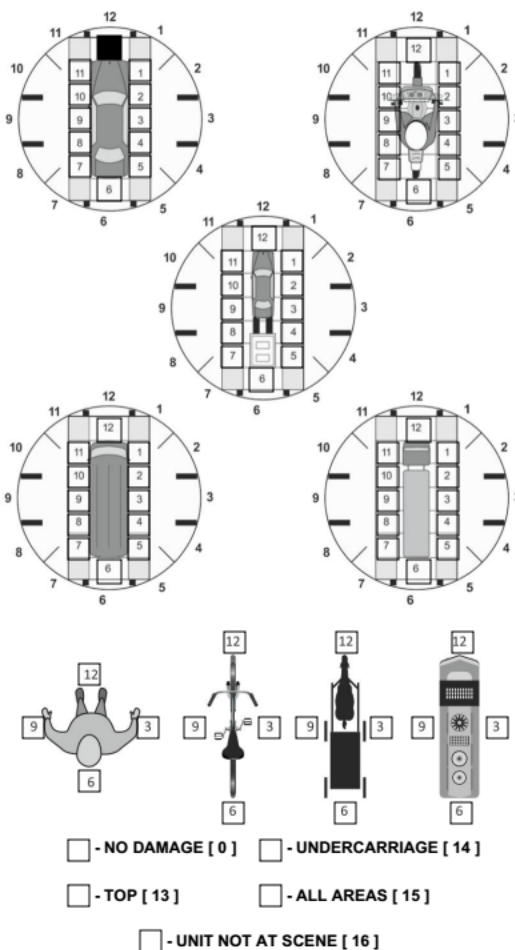

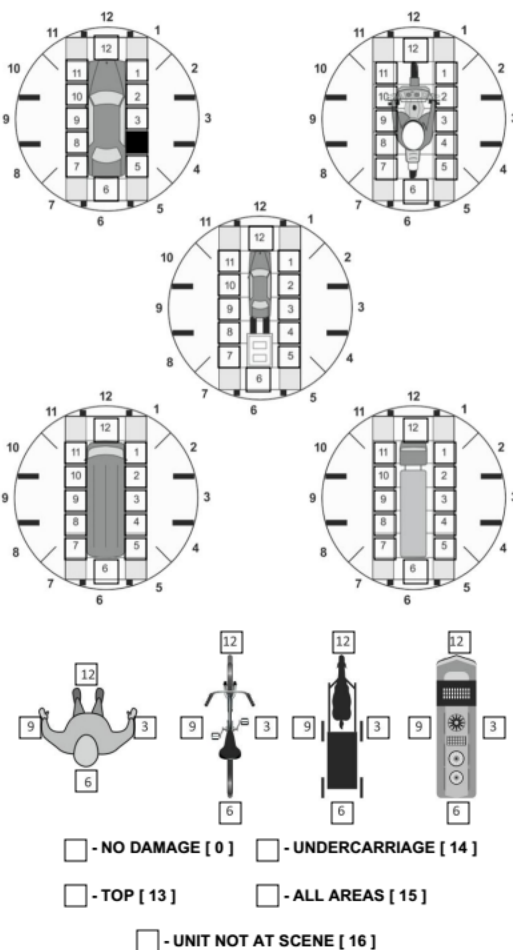
