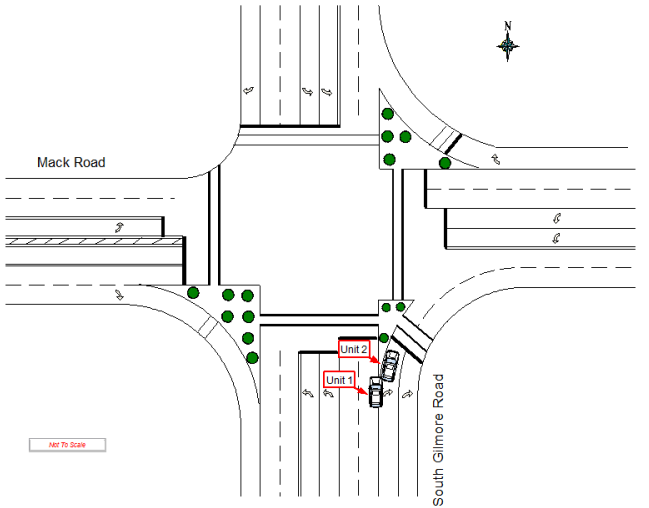

NARRATIVE On December 23, 2023 around 12:46 a.m. Unit 1 and Unit 2 were traveling northbound on S. Gilmore Road. Unit 1 was traveling in the outside thru lane, while Unit 2 was in the inside right turn lane. The driver of Unit 1 failed to maintain control and entered the right turn lane, striking the driver-side rear of Unit 2. Unit 1 failed to stop after the accident and turned left onto Mack Road from the outside thru lane, fleeing the scene. The driver of Unit 1 was issued a citation for Driving in Marked Lanes (331.08a), OVI (333.01a1A), OVI- refusal (333.01a2), Stopping After an Accident (335.12a), and Driving Under Suspension (335.072a). 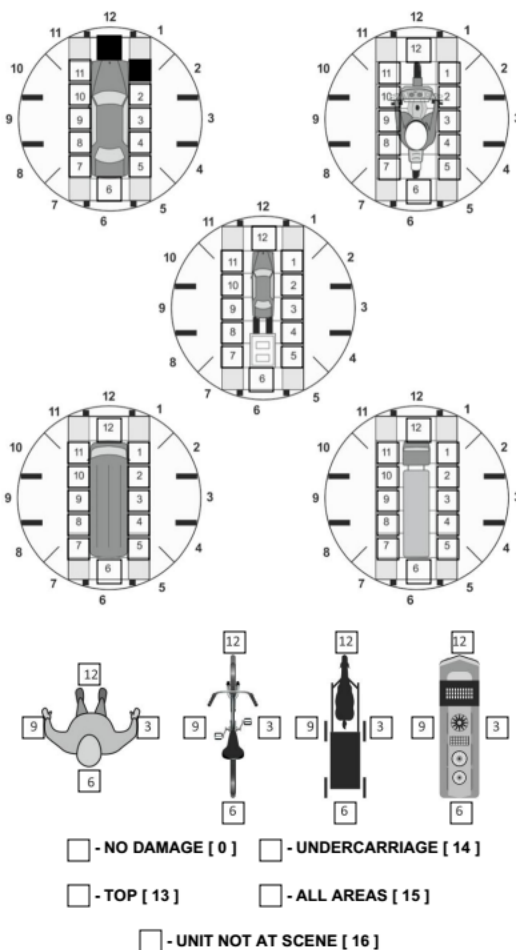
