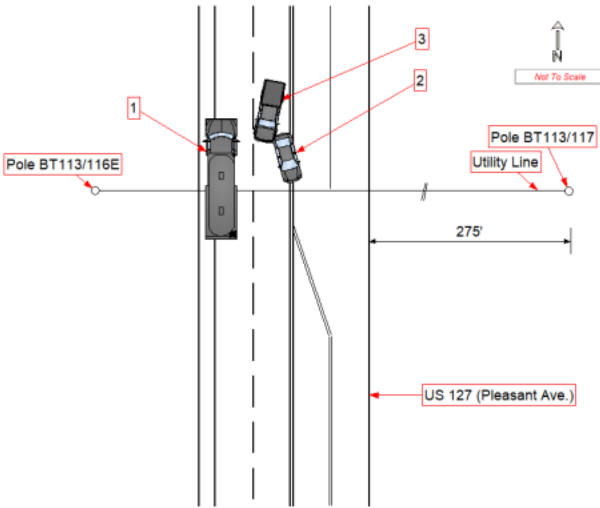

NARRATIVE On December 5, 2023, Unit 1, a commercially contracted vehicle doing utility work, was working in the southbound lanes of US 127. Unit 1 was moved northbound and the boom of Unit #1 pulled down the data line attached to pole # BT113/116E. When the line draped across Unit 1 and into the lanes of travel, Unit 2 was stopped in an abrupt manner to avoid contact with the line. Unit 3 attempted to swerve to avoid Unit 2 and Unit 3 struck the rear of Unit 2. The low voltage line was pulled and snapped a pole, #BT113/117, which was approximately 400' east of the roadway. There was a transformer and power line on the secondary pole that was damaged resulting in the loss of power to several homes. There was a pole between the pole situated close to the roadway where the line was pulled from and the pole that snapped in half. The pole and power line are owned by Duke Energy, 1199 Nilles Rd., Fairfield, OH 45014. The data line is owned by Alta Fiber, 201 E 4th St., Cincinnati, OH 45202.				DIAGRAM

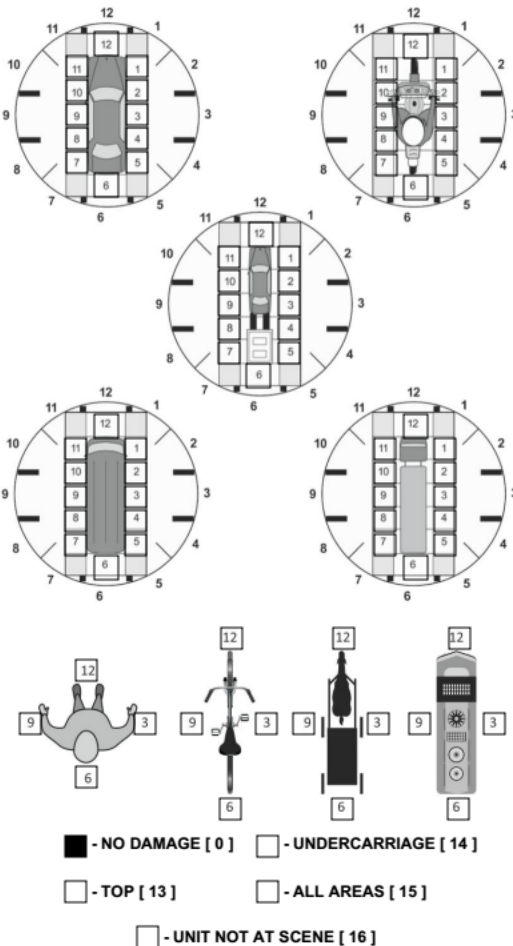

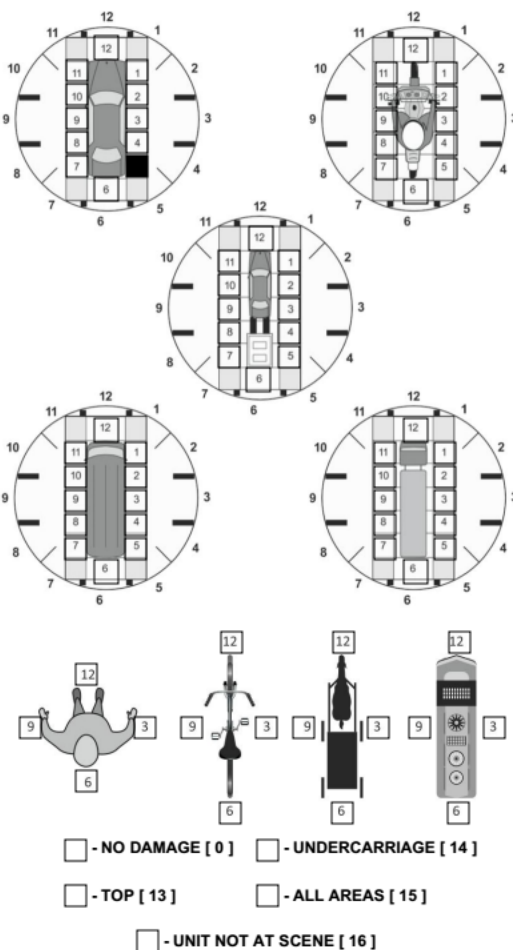
