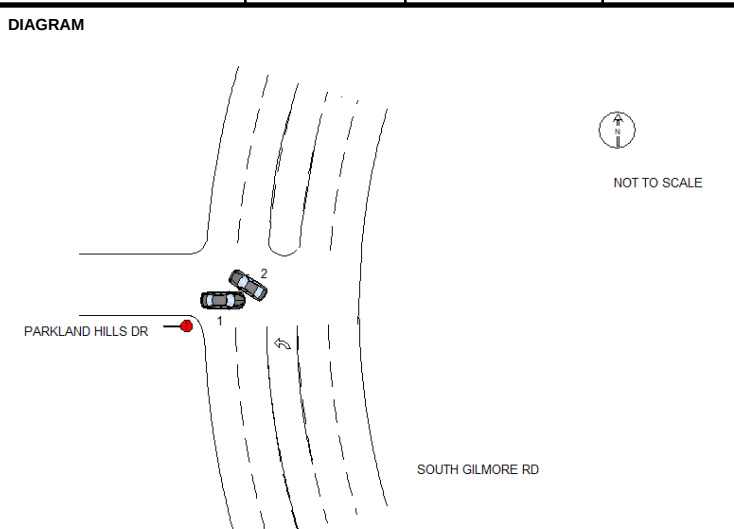

As Unit 2 began to turn left, Unit 1 pulled forward and struck Unit 2 on the driver's side. Unit 1 then left the scene without contacting police or making contact with the driver of Unit 2. 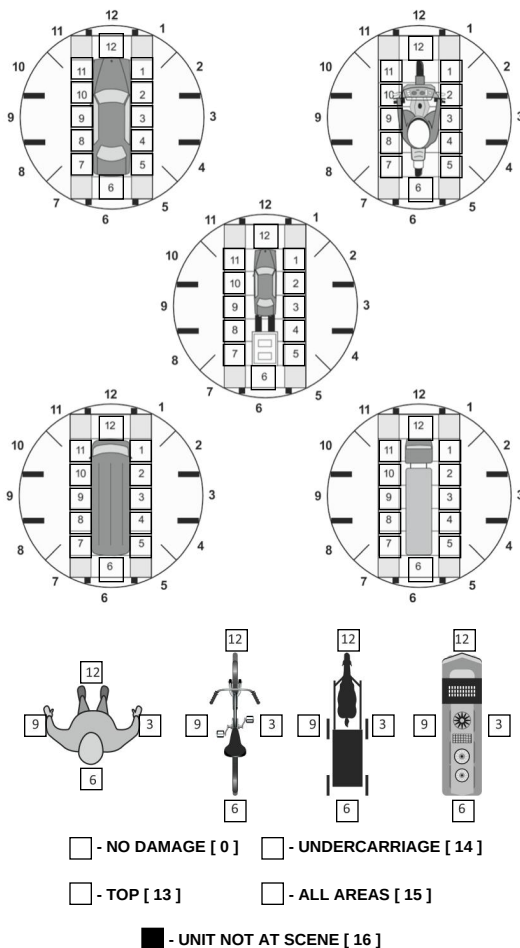

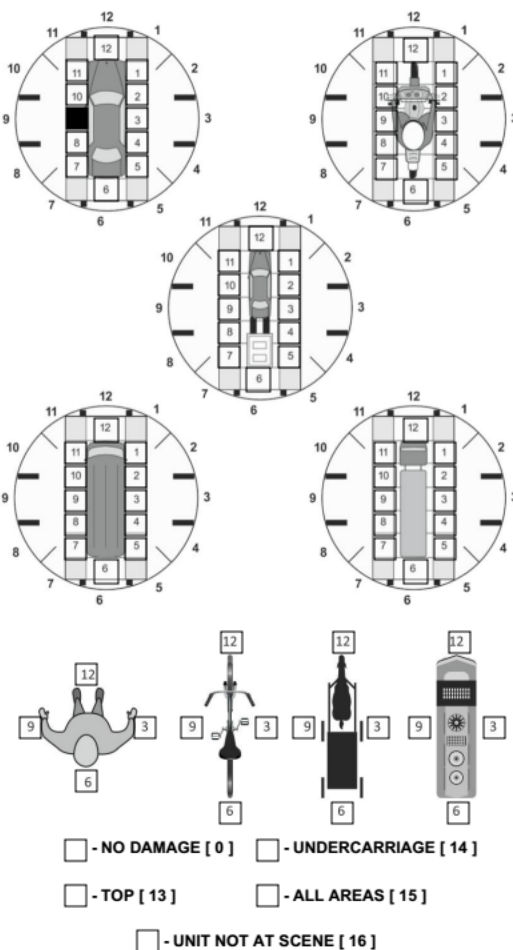
