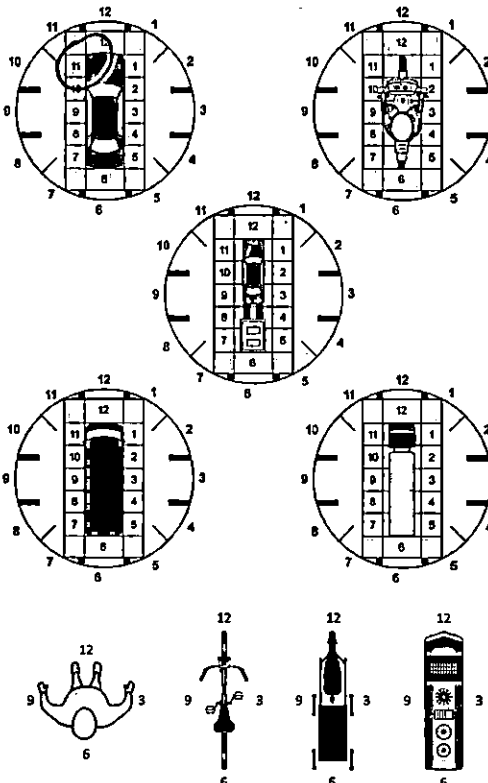

Unit 2 entered the intersection to make a left turn onto Nilles Rd.. The driver yielded to oncoming traffic and waited until the intersection was clear before making the turn. As the traffic signal turned red and the driver executed the turn, Unit 1 was simultaneously given a green arrow to turn right onto Nilles Rd. and did so accordingly. The units then collided and it was unclear which vehicle was at fault.
