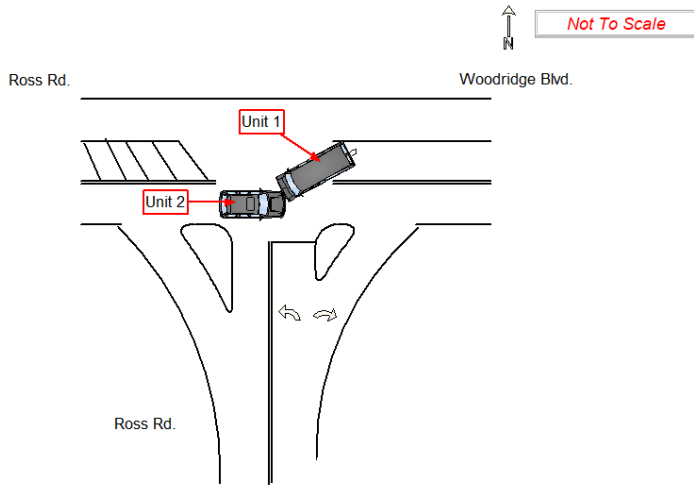

Unit 1 was attempting to make a left turn onto Ross Rd. when it failed to yield, striking unit 2 on the front left corner. The driver of unit 2 said both occupants of unit 1 left the crash on foot. 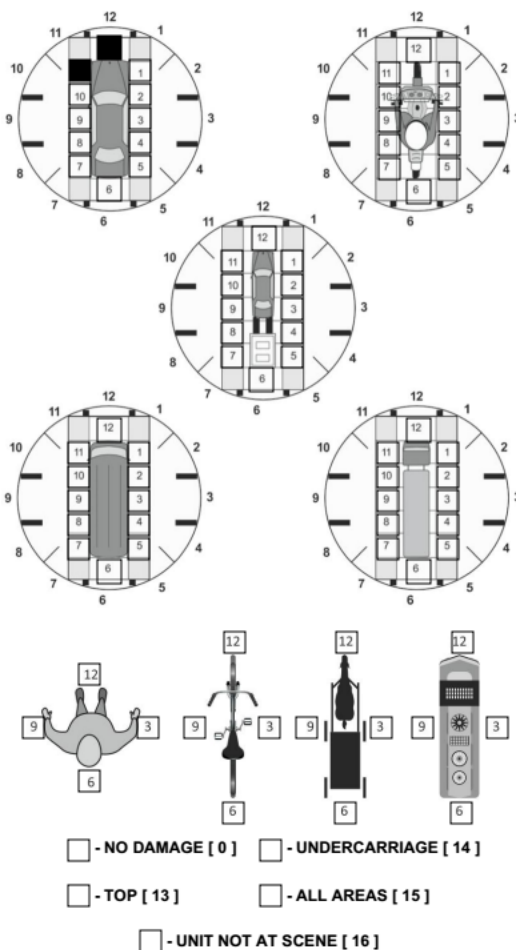
