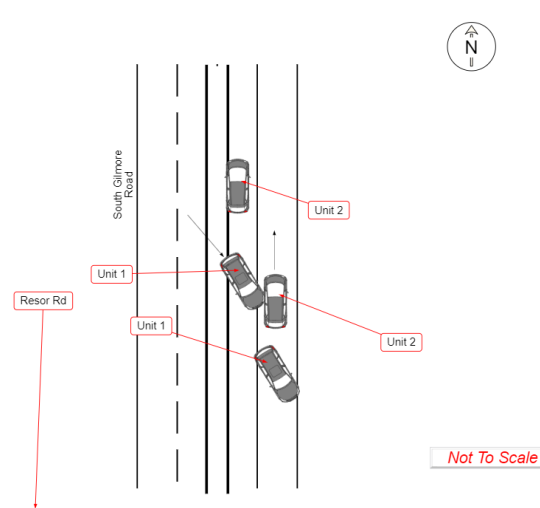

NARRATIVE On 11/10/25 at 7:05 pm Unit 1 was traveling south on South Gilmore Road in the construction zone. Unit 2 was traveling north on South Gilmore Road also in the construction area. Unit 1 did not see the 8 inch plus trench in the roadway that was not blocked off, when he did not see the trench he went left of center over it and struck Unit 2. After striking Unit 2, Unit 1 continued rolling south and came to rest against the guardrail on South Gilmore. Unit 1 was not cited for this crash due to the construction company not having any cones blocking the culvert. 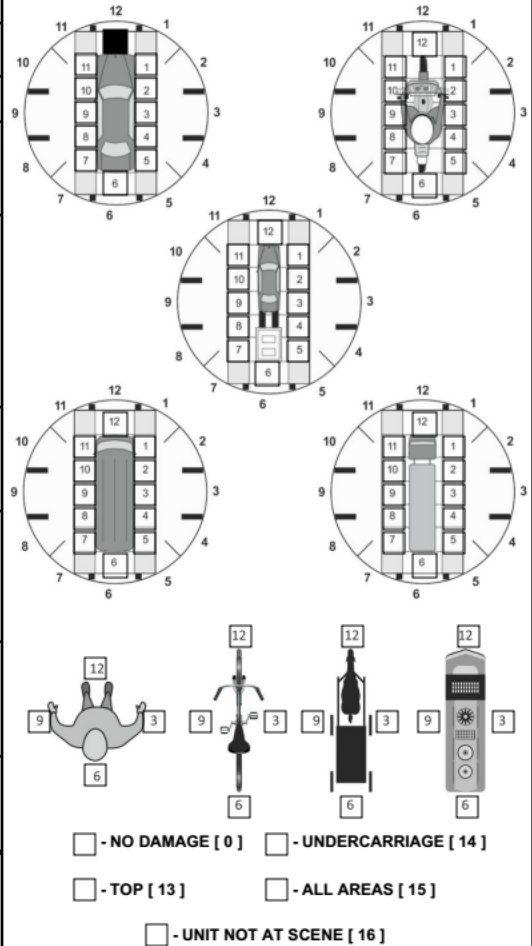

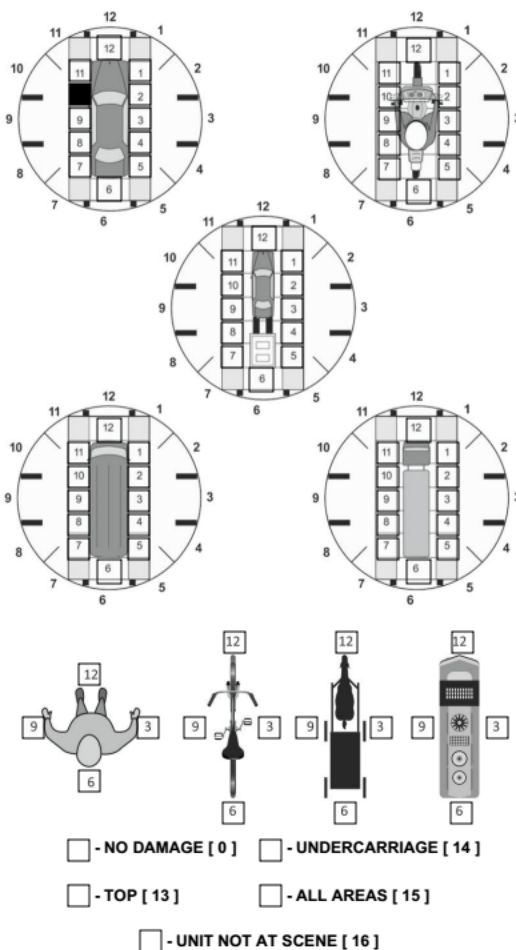
