NARRATIVE On October 23, 2025 at approximately 7:40 p.m. Unit 1 was traveling north on S.R.4 (Dixie Hwy.) and when at 5676 Dixie Hwy. attempted to turn from the inner lane of travel into the outer lane and in so doing, struck Unit 2. Unit 1 then left the scene without exchanging information. The license plate number and photo of the vehicle was obtained, but the registered owner was not driving. The offender was described as a young black male with dreads. On November 24, 2025 the vehicle and driver were located and stopped.
