

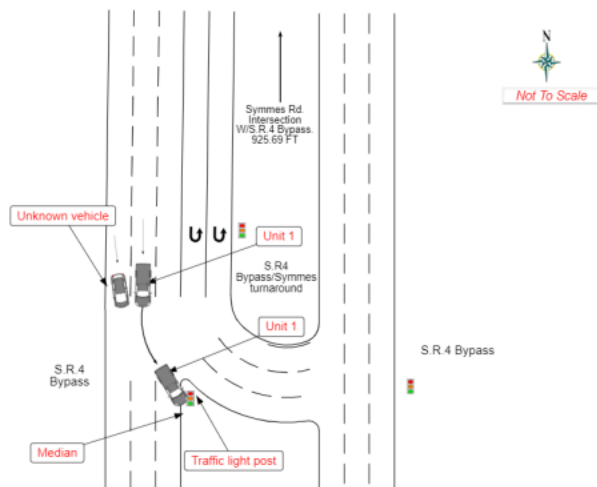

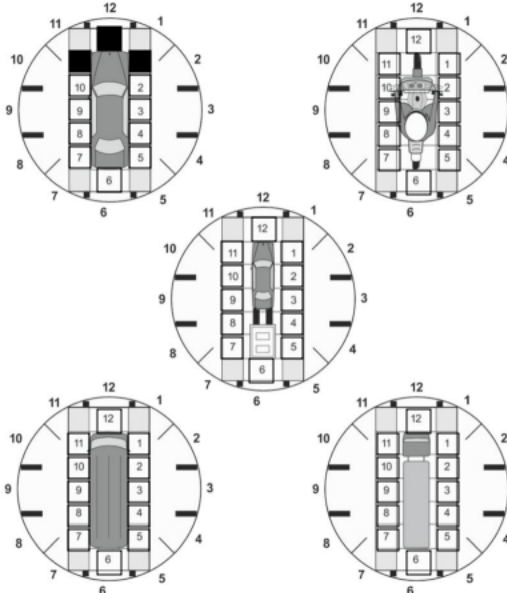
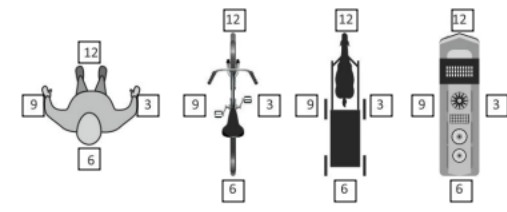
On 12/6/25 around 6:07 PM, Unit 1 was traveling Southbound in the middle lane on S.R.4 Bypass and when near the Bypass 4 Symmes Rd. turnaround, another unknown vehicle made an improper lane change left, into Unit 1's lane of travel. The driver of Unit 1 swerved to avoid the vehicle, causing them to drive off the road left, striking a curb/median, and then a traffic light/post.
