NARRATIVE On 11/11/2025 around 5:23 P.M., Unit 1 was traveling southbound on Ross Road south of Cherry Hill Drive. Units 2, 3, and 4 were all stopped in traffic. The driver of Unit 1 failed to assure clear distance ahead and struck Unit 2 causing Unit 2 to strike Unit 3 and causing Unit 3 to strike Unit 4. The driver of Unit 1 was transported to UC Main Hospital. The driver of Unit 2 was transported to Mercy Fairfield Hospital. Unit 3 was no longer at the scene when officers arrived.
