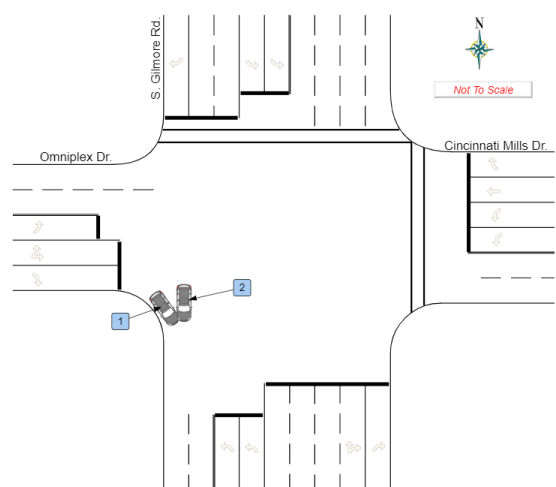

Unit 2 stated Unit 1 ran the red light at the intersection making a right turn in front of Unit 2 causing Unit 2 to strike Unit 1. 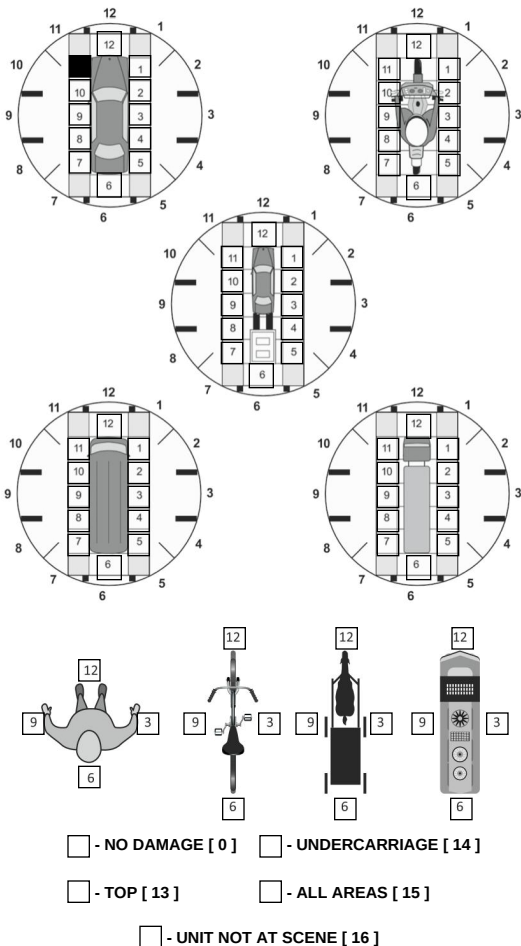

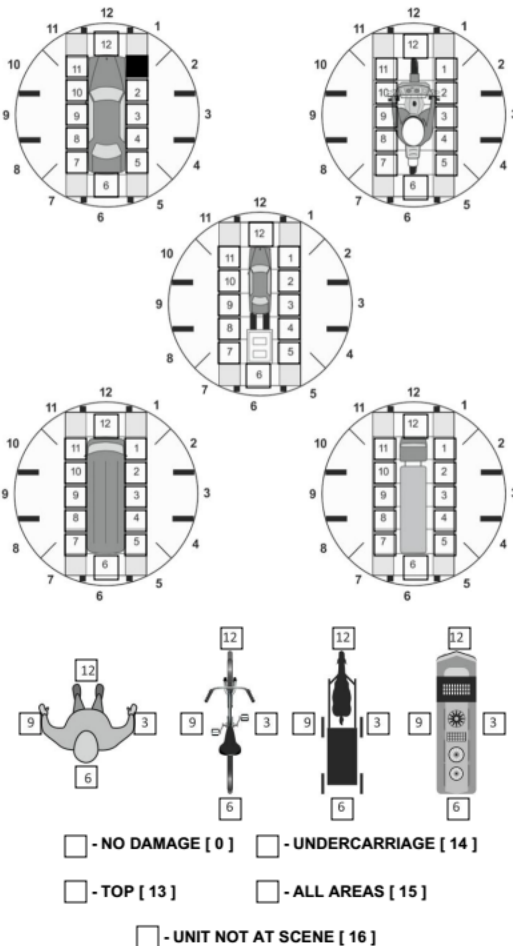
