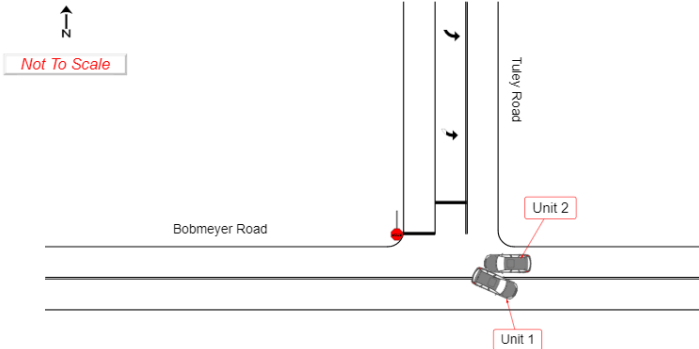

NARRATIVE On 02/03/2026 at approximately 5:30 p.m., Unit #1 was traveling southbound on Tuley Rd. and failed to stop at the stop sign at the intersection of Tuley Rd. and Bobmeyer Rd., causing Unit #2 to strike Unit #1. Unit #2 was traveling westbound on Bobmeyer Rd. at the time of the collision. Following the collision, Unit #1 left the scene of the accident and was later located at his residence. 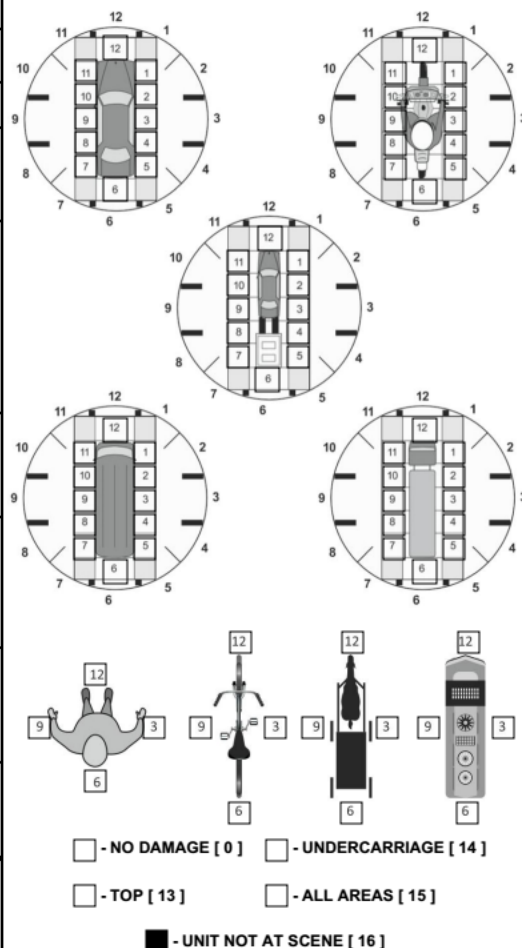
